DESCRIPTION OF SURVEY FOR RUBY M. McCASLIN

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being Lot No. 28 in an unrecorded plat of Wheeler Place addition which is a subdivision including Lots No. 54, 55 and 69 in Mornington's Addition to the City of Zanesville, as recorded in Plat Book 2, Page 84 of said County records and being more particularly described as follows:

Beginning at a railroad spike (set) at the Southwest corner of said Lots #69 in Mornington Addition and #28 in Wheeler Place; thence along the West lines of said Lots #69 & #28, N 13° 27' 00" W (145.96) feet to an iron pin (set) in an existing driveway, said iron pin being the North west corner of said Lot # 28; thence leaving the West line of said Lot #69, and along the North line of said Lot #28, S 65° 29' 40" E (170.79) feet to an iron pin (set) at the Northeast corner of said Lots #28 and #69; thence along the East Lines of said Lots #28 & #69, also parallel to and, (36) feet from as measured at right angles to the East Line of Haessler Street, as described in deed book 740, page 151 of said County records, S 23° 39' 24" W (85.00) feet to an iron pin (set) at the Southeast corner of said Lots #28 & #69; thence along the South lines of said Lots #28 & #69, N 85° 35' 12" W (87.61) feet to the place of beginning containing 0.306 acres.

The bearings within this description are based on the East Line of Haessler Street as described in Deed book 740, page 151 of said County records.


