Situated in the City of Zanesville, Muskingum County, Ohio. Being lots 1 thru 6 of Raddins Addition and a vacated Alley recorded in Plat Book 1 page 52 of the Muskingum County Plat records, being described as follows:

Beginning at a found iron pin marking the Northwest corner of lot 1 of Raddins Addition;

Thence, **N.90°00'00"E.** a distance of 116.00 feet along the South line of Marietta Street to a point on the Northeast corner of a vacated alley, passing a found iron pin on the Northeast corner of Lot 1 at 100.00 feet;

Thence, **S.01°00'00"E.** a distance of 210.00 feet along the East line of said alley to a point on the North line of an alley;

Thence, **S.90°00'00"W.** a distance of 116.00 feet along the north line of said alley to a set rebar on the Southwest corner of lot 6 of Raddins Addition, located on the East line of Sharon Avenue passing the Southeast corner of said lot at 16.00 feet;

Thence, **N.01°00'00"W.** a distance of 210.00 feet along the East line of Sharon Avenue to the point of beginning, passing a found iron pin at 54.40 feet.

The above described parcel contains 0.56 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

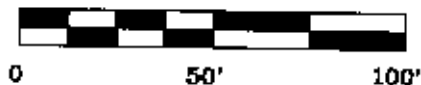

IN THE MUSKINGUM COUNTY PLAT RECORDS.

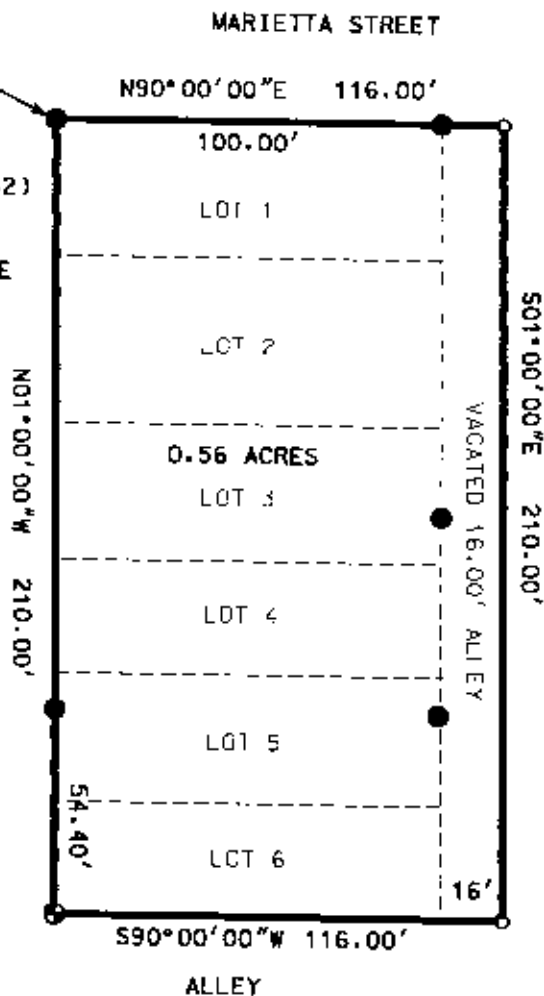
