Commencing at the unmarked Northeast corner of Lot 9 of Balls Subdivision recorded in Plat Book 1, Page 123 and Re-Plat Book 1, Page 186;

- TIE- THENCE South 86 degrees 47 minutes 25 seconds East 128.51 feet along the South side of Sharon Avenue (State Route 146) to an iron pin (set) on the West line of said Muskingum County property further being the Northeast corner of the Lester J Hanna Jr property recorded in Deed Book Volume 1073, Page 567, and being the place of beginning for the property herein intended to be described;
- #1- THENCE North 04 degrees 12 minutes 35 seconds East 34.54 feet extending the common line of said Muskingum County and Hanna properties to an unmarked point in the centerlline of Sharon Avenue;
- #2- THENCE along a curve to the left having, a chord bearing North 88 degrees 00 minutes 43 seconds East 54.85 feet, a radius of 1532.56 feet, and arc length of 54.85 feet, along said centerline to the extension of the common line for said Muskingum County property and for the Darion R Trott TOP Randall A Kopchak property recorded in Official Record Volume 2120, Page 232;

- #4- THENCE South 85 degrees 54 minutes 29 seconds West 68.86 feet along the South line of said Muskingum County property to an unmarked point in Slago Run and common Southern corner for said Muskingum County and Hanna properties;
- **#5-** THENCE North 04 degrees 12 minutes 35 seconds East 96.10 feet along said properties to the place of beginning, containing 0.18 acres, of which 0.04 acres are within the right of way of Sharon Avenue (State Route 146).
