ALL OF AUDITORS PARCEL
81-54-01-04-000 (0.20 Acres)

Situated in lot 1 of Best Subdivision, Section 5, T-12, R-13, City of Zanesville, Muskingum County, Ohio.

Commencing at the Southeast corner of lot 1 of Best Subdivision (D.B. E, Pg. 457); thence, N.88°40'25"W. a recorded distance of 146.91 feet along the North line of Sharon Avenue to a found iron pin; thence, N.85°32'45"W. a distance of 99.81 feet along the North line of Sharon Avenue to a found iron pin, BEING THE POINT OF BEGINNING;

Thence, N.85°32'45"W. a distance of **53.54 feet** along the North line of Sharon Avenue to a found iron pin on the Southeast corner of the lands, now or formerly, owned by R. Gallagher (1704/777);

Thence, N.04°14'05"E. a distance of **166.02 feet** along the East line of said Gallagher lands to a set rebar on the South line of a 16.0' wide alley;

Thence, S.85°32'45"E. a distance of **53.54 feet** along said alley to a set rebar on the Northwest corner of the lands, now or formerly, owned by R. Wentworth (1836/265);

Thence, S.04°14'05"W. a distance of **166.02 feet** along said Wentworth lands to the point of beginning.

The above described parcel contains 0.20 Acres, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

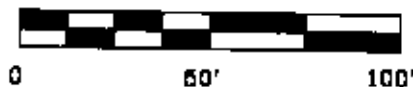
SURVEY PLAT FOR MICHAEL SIMS

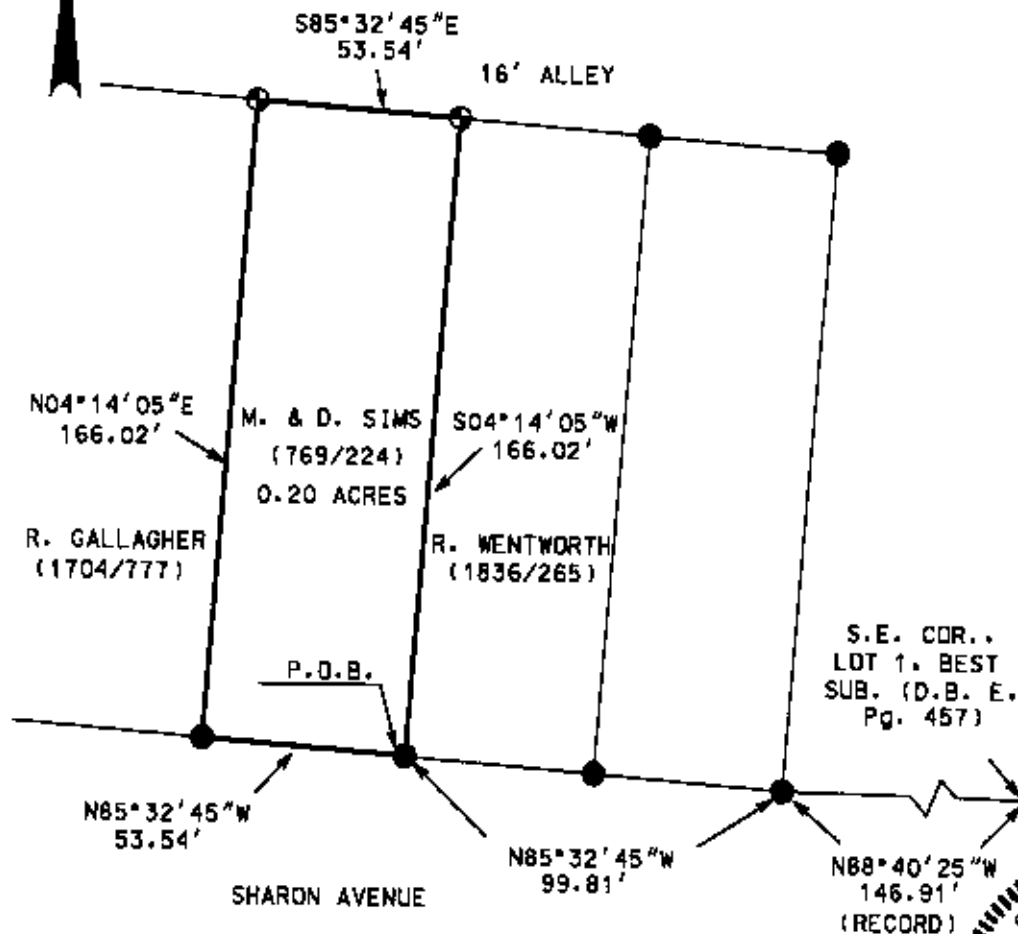

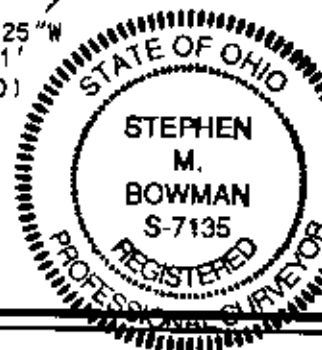
