TO VACATE THAT PORTION OF AN UNNAMED  
ALLEY LYING WEST OF LOT 54 IN THE EAST  
GREENWOOD TERRACE ADDITION OF THE CITY  
OF ZANESVILLE FROM THE SOUTH RIGHT-OF-WAY  
LINE OF WHEELING AVENUE TO THE SOUTH LINE  
EXTENDED OF SAID LOT 54.

WHEREAS, the Zanesville Planning Commission has considered  
and unanimously approved the vacation hereinafter set forth; and

WHEREAS, in the opinion of this Council there is good cause  
for vacating the portion of alley hereinafter described and such  
vacation will not be detrimental to the general interest; and

WHEREAS, proper notification of the intent of Council to  
vacate such portion of said alley has been given and published in  
the local newspaper of general circulation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City  
of Zanesville, State of Ohio; that

SECTION ONE: The following described portion of alley be  
and the same is hereby vacated:

Situated in the City of Zanesville, Muskingum County,  
Ohio:

The portion of an unnamed alley lying west of Lot 54  
in the East Greenwood Terrace Addition of the City  
of Zanesville from the south right-of-way line of  
Wheeling Avenue to the south line extended of said  
Lot 54.

The described portion of said alley is delineated  
in Plat Book 5, Page 51 of the Plat Records of  
Muskingum County, Ohio.

SECTION TWO: The Director of Public Service is hereby  
instructed to prepare a vacation plat of said vacated portion of the  
unnamed alley described herein and the Clerk of Council is instructed  
to endorse upon such plat the action of this Council in vacating  
the described portion of alley and to cause said plat to be recorded  
in the Office of the Recorder of Muskingum County, Ohio.

SECTION THREE: This Ordinance shall take effect upon the  
approval of the Mayor and from and after the earliest period allowed  
by law.
