SITUATED IN THE STATE OF CHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF LOTS 17, 18, AND 19 OF THE EAST GREENWOOD TERRACE ADDITION TO THE CITY OF ZANESVILLE, AS RECORDED IN PLAT BOOK 4, PAGE 101; AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1035, PAGE 550; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE NORTHWEST CORNER OF LOT \$17 OF SAID SUBDIVISION, THENCE, SOUTH 04 DEGREES - 36 MINUTES - 50 SECONDS WEST, 75.04 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 85 DEGREES - 19 MINUTES - 00 SECONDS EAST, 132.05 FEET TO AN IRON PIN SET ON THE WEST LINE OF SOUTHARD AVENUE, PASSING AN IRON PIN FOUND AT 44.00 FEET; THENCE, SOUTH 04 DEGREES - 40 MINUTES - 23 SECONDS WEST, 45.00 FEET ALONG SAIO STREET TO AN IRON PIN SET; THENCE, NORTH 85 DEGREES - 19 MINUTES - 00 SECONDS WEST, 132.00 FEET ALONG THE NORTH LINE OF A SIXTEEN (16) FOOT ALLEY TO AN IRON PIN SET; THENCE, NORTH 04 DEGREES - 36 MINUTES - 50 SECONDS EAST, 45.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.136 ACRES MORE OR LESS.


