TRACT #1: 222 7th ST

Beginning at an iron pin set on the northwest corner of Lot 26 of Roe's Addition (Plat Book A-O, Page 192), also being the northwest corner of Lot 1 of Foster's Subdivision of Lot's 22-26 of Roe's Addition (Deed Book "X", Page 261), being on the east line of 7TH Street (49.5' wide);

thence along the east line of 7th Street North 00 degrees 00 minutes 00 seconds East 30.00 feet to an iron pin set, being the southwest corner of D.H. & E.L. Wolfe (DR 470-416);

thence leaving the east line of 7th Street and along the south line of D.H. & E.L. Wolfe (DR 470-416) North 90 degrees 00 minutes 00 seconds East 63.00 feet to an iron pin set;

thence South 00 degrees 00 minutes 00 seconds West 30.00 feet to an iron pipe found on the north line of Lot 1 of Foster's Subdivision of Lot's 22-26 of Roe's Addition (Deed Book "X", Page 261);

thence along the north line of Lot 1 of Foster's Subdivision of Lot's 22-26 of Roe's Addition (Deed Book "X", Page 261) North 90 degrees 00 minutes 00 seconds West 63.00 feet to the principal place of beginning, containing 0.043 acres, more or less.

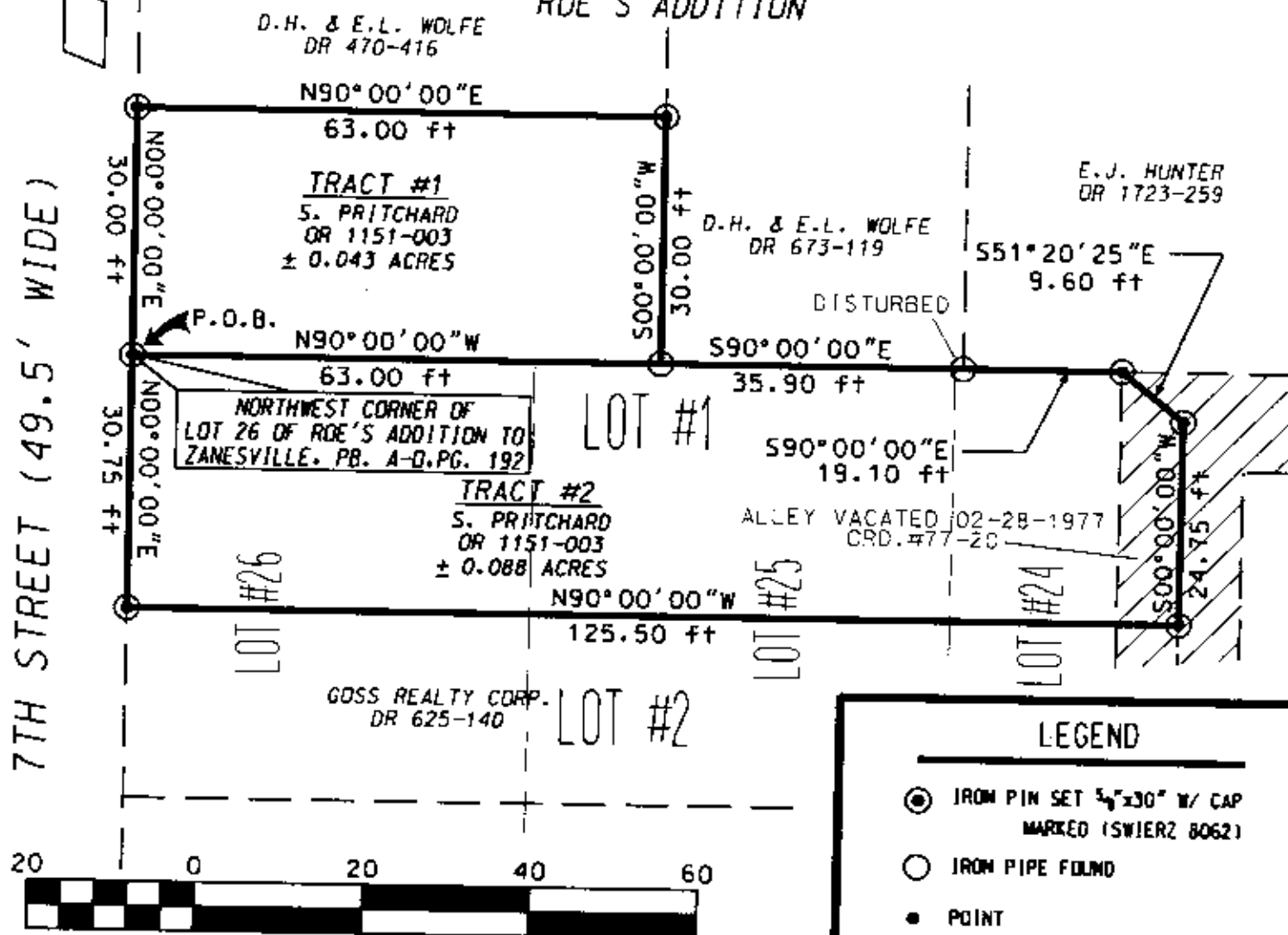
