DEED DESCRIPTION

The following Real Estate is situated in the State of Ohio, County of Muskingum, City of Zanesville and is bounded and described as follows:

Being a part of Lots Nine (9) and Ten (10) of the Fourteenth (14) Square of the City of Zanesville as designated and delineated on Plat Book A-O, Page 5, being the same premises described in Volume 504, Page 570 of the Muskingum County Deed Records, beginning for reference at the point of intersection of the south line of Main Street and the west line of Sixth Street, said point also being the northeast corner of Lot 9; thence West 49.5 feet along the south line of Main Street (the basis of bearings herein described) to a point and the principal place of beginning; thence South 0 degrees 15 minutes West 80.0 feet to a point; thence East 26.5 feet to a point; thence South 0 degrees 15 minutes West 1.5 feet to a point; thence West 26.5 feet to a point; thence South 0 degrees 15 minutes West 40.0 feet to a point; thence West 20.0 feet to a point; thence North 0 degrees 15 minutes East 121.5 feet to a point on the south line of Main Street; thence East 20.0 feet along said south line to the principal place of beginning, containing 8.057 acres, more or less, subject to all highways and easements.


