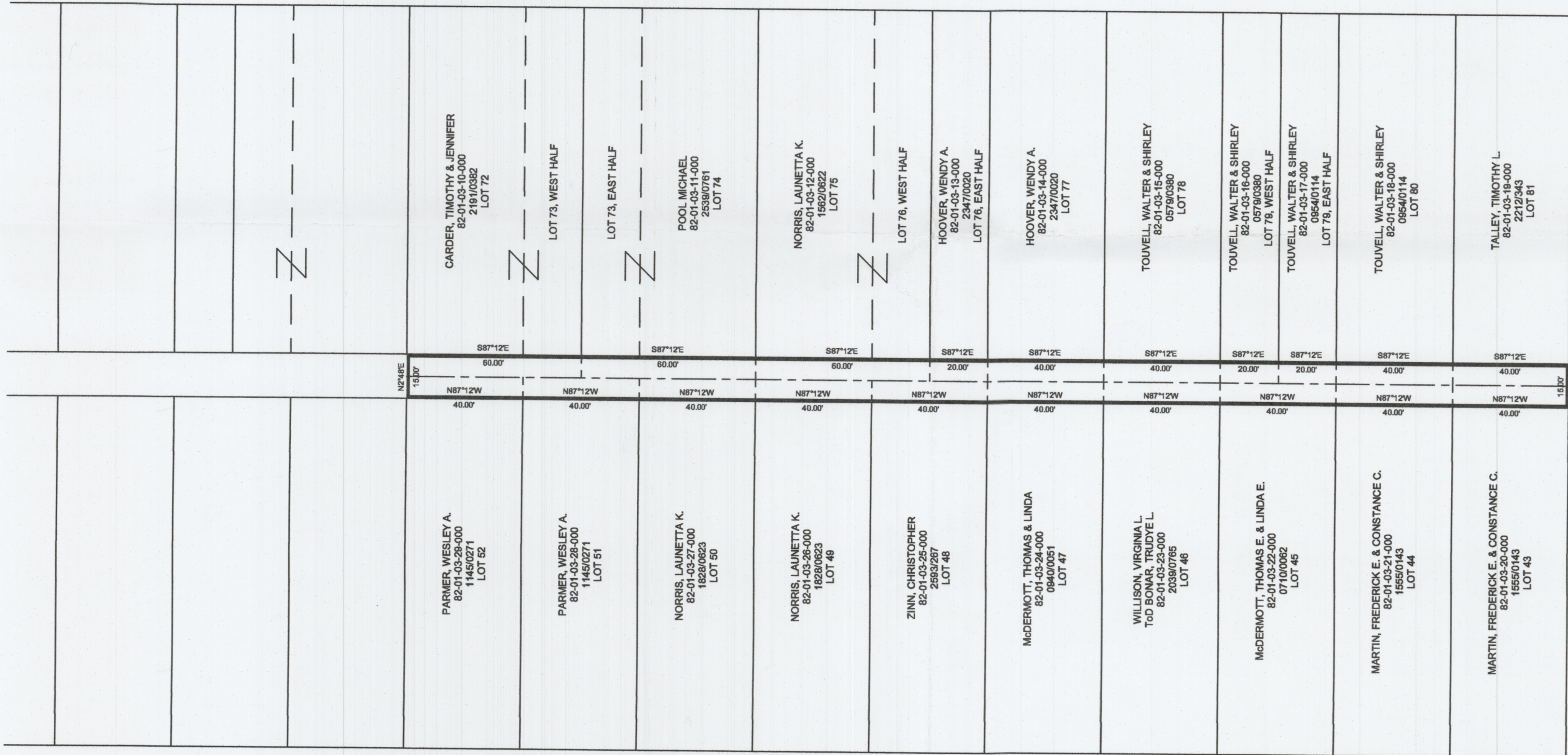

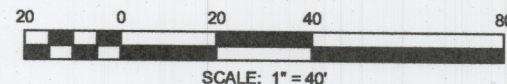

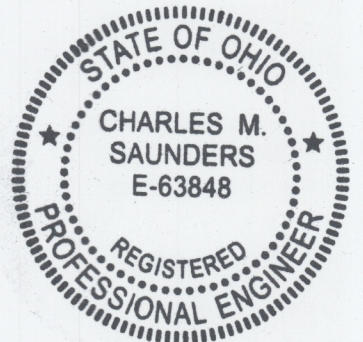


FEDERAL AVENUE (FORMERLY WEBSTER STREET) (40' R/W)
