Commencing at a concrete monument at the Northwest Corner of Lot 117 of Lindbergh Allotment recorded in Plat Book 2, Page 1A; Thence South  $84^{\circ}26'00''$  East along Lindbergh Ave. 600.00 feet to a concrete monument at the Northeast Corner of Lot 128; Thence continuing along Lindbergh Ave. South  $81^{\circ}34'15''$  East 100.12 feet to an iron pin found; Thence leaving Lindbergh South  $5^{\circ}34'00''$  West 160.00 feet to an iron pin found on the North Line of Seborn Ave.; Thence along Seborn Ave. South  $83^{\circ}47'14''$  East 99.60 feet to a point; Thence North  $6^{\circ}12'46''$  East 61.69 feet to an iron pin set the place of beginning; Thence North  $6^{\circ}12'46''$  East along J&D Abbott Vol. 557, Page 581, 58.35 feet to an iron pin set; Thence South  $83^{\circ}47'14''$  East 50.00 feet to an iron pin set on the West Line of Pine Street; Thence along Pine Street South  $6^{\circ}12'46''$  West 58.60 feet to an iron pin set; Thence North  $83^{\circ}30'23''$  West along the South line of a 22'X44' garage 50.00 feet to the place of beginning containing 0.067 acres more or less:

Also the following easement: Commencing at the intersection of the North line of Seborn and the West line of Pine Street; Thence North  $6^{\circ}12'46''$  East along Pine Street 61.40 feet to an iron pin the place of beginning; Thence South  $6^{\circ}12'46''$  West along Pine Street 4.00 feet to a point; Thence leaving Pine Street North  $83^{\circ}30'23''$  West along a concrete side walk 11.80 feet to a point; Thence across side walk North  $6^{\circ}12'46''$  East 4.00 feet to a point on the West side of a 3.00 foot wide door; Thence South  $83^{\circ}30'23''$  East along concrete block building 11.80 feet to the place of beginning; This easement given for access to a door on the South side of a 44X22 foot garage building. The grantee of this easement to share in the maintenance of said 4 foot walkway.

Bearings are based on the North line of Lindbergh Ave. along Lot 117 through Lot 128 bearing South  $84^{\circ}26'00''$  East.
