Situated in the State of Ohio, County of Muskingum, City of Zanesville and being part of Out Lot 41 of Putnam (Plat Book "A-O", Page 2), also being part of the lands now owned by Charles Wyatt as recorded in Deed Record 1118-23 of the Muskingum County Recorders office, which is all of Muskingum County Auditors Parcel Number 82-30-03-18-000, more particularly described as follows.

Beginning for reference at an iron pipe found on the southwest corner of said Out Lot 41, also being on the north line of Pershing Road, thence going with said north line of Pershing Road, South 86 degrees 45 minutes 00 seconds East, 239.85 feet to an iron pin found, passing iron pins found at 123.99 feet and 204.85 feet;  
thence leaving said north line of Pershing Road and going with the east line of the lands now owned by Dale R. & Linda Wyatt, OR 1615-457, North 03 degrees 03 minutes 39 seconds East 122.21 feet to an iron pin set and the principal place of beginning;  
thence continuing with the east line of said Dale R. & Linda Wyatt's lands, North 03 degrees 03 minutes 39 seconds East, 37.79 feet to an iron pin set on the south line of a 15 foot wide alley;  
thence with the south line of said alley, South 86 degrees 46 minutes 36 seconds East, 49.96 feet to an iron pin found on the west line of Clifford Avenue;  
thence with the west line of said Clifford Avenue, South 03 degrees 13 minutes 24 seconds West, 37.79 feet to an iron pin set;  
thence through the lands of said Charles Wyatt and with the common line of Muskingum County Parcel Numbers 82-30-03-18-000 and 82-30-03-19-000, North 86 degrees 46 minutes 36 seconds West, 49.85 feet to the point of beginning, containing 0.043 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 0.043 acre parcel is based on a field survey made by McPeek Land Surveying on November 8th, 2013.




