COMMENCING AT AN EXISTING IRON PIN (BOLT) AT THE NORTHEAST CORNER OF SAID LOT 31, SAID POINT BEING AT THE SOUTHWEST CORNER OF PINE STREET AND BEXLEY STREET;

THENCE WITH THE WEST LINE OF SAID PINE STREET, SOUTH 00 DEGREES 30 MINUTES 18 SECONDS EAST (BASIS OF BEARINGS) 170.00 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID WEST LINE, SOUTH 00 DEGREES 30 MINUTES 18 SECONDS EAST 100.72 FEET TO A POINT;

THENCE WITH THE NORTH LINE OF A TRACT CONVEYED TO A. HAMMELL (DEED VOLUME 1132, PAGE 565), SOUTH 89 DEGREES 33 MINUTES 21 SECONDS WEST 165.00 FEET TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (AXLE) AT 3.29 FEET;

THENCE WITH THE WEST LINE OF THE ABOVE SAID LOT 32 AND LOT 33, NORTH 00 DEGREES 30 MINUTES 18 SECONDS WEST 47.86 FEET TO AN IRON PIN SET;

THENCE WITH THE NORTH LINE OF A TRACT CONVEYED TO RUTH THOMSEN (DEED VOLUME 708, PAGE 8), NORTH 89 DEGREES 32 MINUTES 02 SECONDS EAST 5.92 FEET TO AN IRON PIN SET;

THENCE WITH THE WEST LINE OF THE TRACT CONVEYED TO RUTH THOMSEN (DEED VOLUME 700, PAGE 117), NORTH 00 DEGREES 30 MINUTES 18 SECONDS WEST 52.79 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH LINE OF THE TRACT CONVEYED TO ST. PAUL AME CHURCH (DEED VOLUME 1035, PAGE 460), NORTH 89 DEGREES 32 MINUTES 02 SECONDS EAST 159.08 FEET TO THE PLACE OF BEGINNING.

CONTAINING 0.374 MORE OR LESS ACRES, SUBJECT TO ALL OTHER APPLICABLE EASEMENTS. ALSO THE RIGHT TO USE A STRIP OF LAND 5.70 FEET IN WIDTH OFF THE WEST SIDE OF LOT NUMBER 31 AND NUMBER 32 AND ADJACENT TO THE ABOVE DESCRIBED TRACT AS DESCRIBED IN DEED VOLUME 700, PAGE 117 OF THE MUSKINGUM COUNTY DEED RECORDS.
