LEGAL DESCRIPTION PARCEL 82-39-02-02-000

Being part of Lot 34 of Perry's 1st Subdivision, now or formerly conveyed to Lori Wilson, by a deed recorded in Official Record 2136, Page 688 of the records of the Muskingum County Recorder's Office, more fully described as follows:

Commencing at an axle found on the southeast corner of Lot 33 of Perry's 1st Subdivision, as recorded in Plat Book 2 Page 20 of the records of the Muskingum County Recorder's Office, said corner also being the northeast corner of Lot 3 of Guy's Subdivision, as recorded in Plat Book 7 Page 8 of the records of the Muskingum County Recorder's Office, said corner also being on the westerly line of Pine Street;

Thence North 86°35′18″ West along the southerly line of Perry's 1st Subdivision, said line also being the northerly line of Guy's Subdivision, a distance of 159.38 feet to a Capped Rebar Set on the southeasterly corner of the subject parcel, on the northerly line of a parcel of land now or formerly conveyed to Roger & Christine Carper, by a deed recorded in Official Record 1795, Page 78 of the records of the Muskingum County Recorder's Office, on the southwesterly corner of a 19 ft wide alley, the POINT OF BEGINNING of the parcel herein described;

Thence the following 4 courses along the subject parcel:

- 1. Along the northerly lines of 3 parcels of land now or formerly conveyed to Roger & Christine Carper, by deeds recorded in Official Record 1795, Page 78, and Deed Volume 1050 Page 520 of the records of the Muskingum County Recorder's Office, North 86°35'18" West, a distance of 85.94 feet to a 5/8 inch diameter rebar found bent;
- 2. Along the easterly line of land now or formerly conveyed to Sally A. Tompkins, by a deed recorded in Official Record 2988, Page 709 of the records of the Muskingum County Recorder's Office, North 03°03'10" East, a distance of 38.41 feet to a 5/8 inch diameter rebar found capped "RLS 5410";
- 3. Along the southerly right of way of Nancy Avenue (Formerly Virginia Ave) South 86°57′44″ East, a distance of 85.94 feet to a 5/8 inch diameter rebar found capped "RLS 5410";
- 4. Along the westerly line of an 19 foot wide alley South 03°03′10″ West, a distance of 38.97 feet, returning to the POINT OF BEGINNING.

The above described area is contained all within the Muskingum County Auditor's Parcel Number 82-39-02-02-000, and contains 0.076 acres (3,325 square feet) of land.

Capped Rebar Set in the above description are 5/8 inch x 30 inch long rebar set with pink plastic caps stamped "UTI BOUNDARY MONUMENT".
