## DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, being a resurvey of Lelia D. Smock Vol. 376 Pg. 333, being part of Lot 101 of the Charles C. Russell's Plat Book 2 Pg. 1, and more particularly described as follows:

Beginning at an iron pin set at the Southwest Corner of Lot 101; thence along Augusta Street North 40 Degrees 00 Minutes 00 Seconds East 78.14 feet to an iron pin set; thence leaving Augusta Street South 51 Degrees 00 Minutes 00 Seconds East 54.03 feet to an iron pin set; thence South 40 Degrees 00 Minutes 00 Seconds West 100.41 feet to an iron pin found, referenced by an iron pin found at the Southeast Corner of Lot 102 at South 28 Degrees 27 Minutes 18 Seconds East; thence along Brighton Blvd. North 28 Degrees 27 Minutes 18 Seconds West 58.08 feet to an iron pin set and the place of beginning, containing 0.11 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the R/W of Brighton Blvd. as being North 28 Degrees 27 Minutes 18 Seconds West.


