Situated in the State of Ohio, County of Muskingum, City of Zanesville, being a resurvey of Venzella M. & John E. Norris Vol. 1142 Pg. 675 and a resurvey of Venzella M. Norris Vol. 1159 Pg. 145, being all of Lot 7 and part of Lot 8 of the Plat of Olympus Deed Book 12 Pg. 186, and more particularly described as follows:

Beginning at a railroad spike set at the Southeast Corner of Lot 7; thence along the North Line of Muskingum Ave. (66' R/W) North 86 Degrees 44 Minutes 17 Seconds West 69.94 feet to a point in the center of a partition wall, passing the Southeast Corner of Lot 8 at 40.00 feet; thence with the partition wall along the East Line of Harold J. McCarty Jr. North 01 Degrees 01 Minutes 16 Seconds West 83.75 feet to a point in said wall; thence along the South Line of Main Street (80' R/W) North 88 Degrees 15 Minutes 03 Seconds East 63.41 feet to a railroad spike set, passing the Northwest Corner of Lot 7 at 22.41 feet; thence along the East Line of Lot 7 South 05 Degrees 03 Minutes 37 Seconds East 90.00 feet to the place of beginning, containing 0.132 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar 30 inches long, with plastic ID caps.

Bearings are based on the East Line of Lot 7 as being South 05 Degrees 03 Minutes 37 Seconds East.


