FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE NORTHWEST CORNER OF SAID LOT 20, THE TRUE POINT OF BEGINNING FOR THIS PARCEL; THENCE, NORTH 88 DEGREES - 10 MINUTES - 01 SECONDS EAST, 155.20 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 29 DEGREES - 56 MINUTES - 52 SECONDS EAST, 63.43 FEET TO A POINT; THENCE, SOUTH 53 DEGREES - 51 MINUTES - 51 SECONDS WEST, 27.35 FEET TO AN IRON PIN FOUND; THENCE, NORTH 34 DEGREES - 40 MINUTES - 08 SECONDS WEST, 38.01 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 88 DEGREES - 09 MINUTES - 03 SECONDS WEST, 40.85 FEET TO AN AXLE FOUND; THENCE, SOUTH 52 DEGREES - 10 MINUTES - 38 SECONDS WEST, 92.98 FEET TO AN IRON PIN FOUND ON THE EAST LINE OF CULBERTSON AVENUE; THENCE, ALONG SAID CULBERTSON AVENUE, NORTH 37 DEGREES - 45 MINUTES - 43 SECONDS WEST, 42.95 FEET TO AN IRON PIN SET; THENCE, CONTINUING ALONG SAID AVENUE, NORTH 02 DEGREES - 24 MINUTES - 54 SECONDS WEST, 59.30 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.237 ACRES MORE OR LESS.

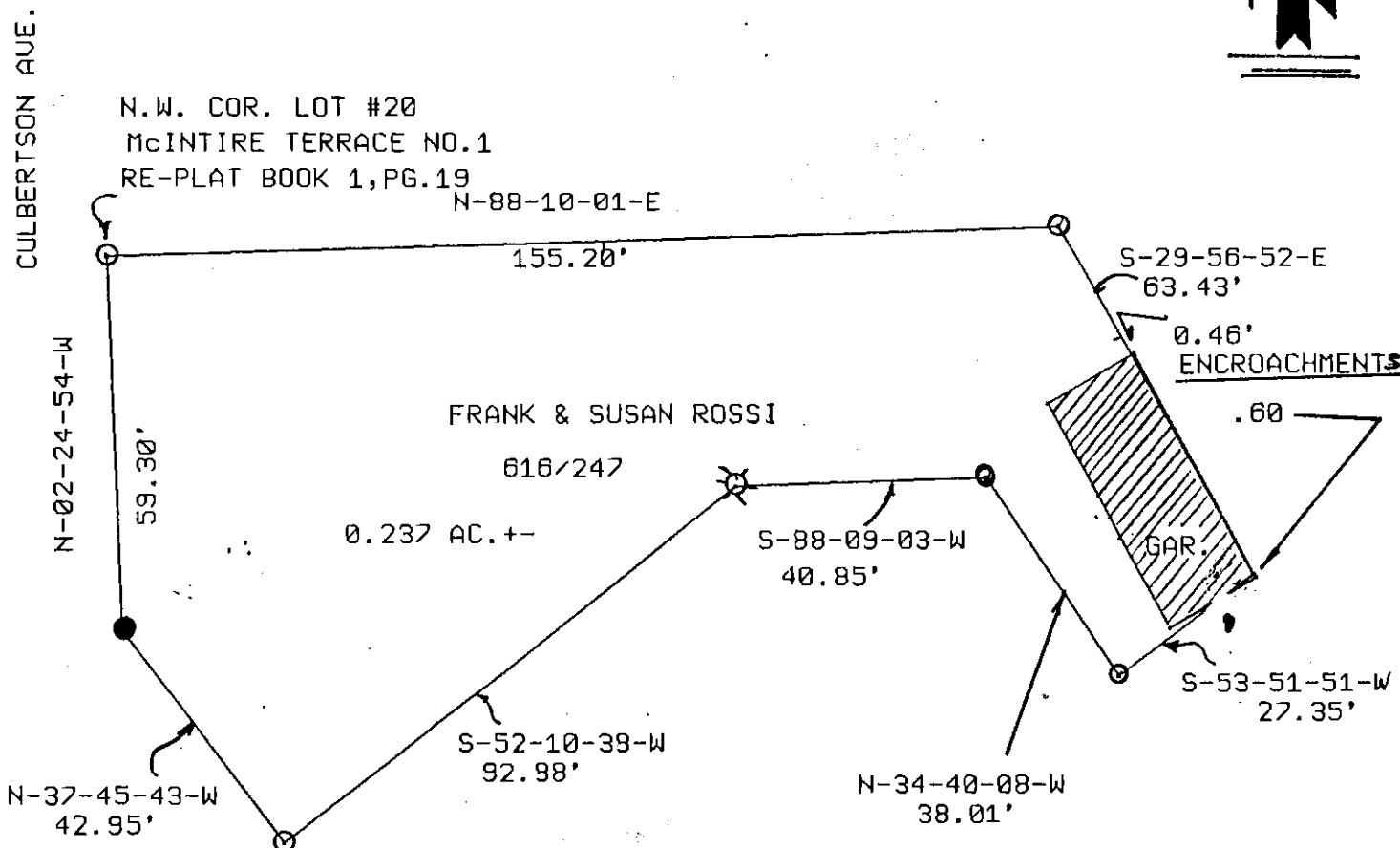
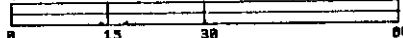
