

## Survey for Mary Michele Young

Situated in lot 8 of Gibbon's Subdivision, as recorded in Plat Book 2, Page 58, of the Muskingum County Records, and in lot 34 of McIntire Terrace No. 1, as recorded in Plat Book 1, Page 68 and Re-plat Book 1, Page 19, the City of Zanesville, Muskingum County, State of Ohio, being bounded and described as follows:

Commencing for reference at an iron pin set (Eicher); marking the Northwest corner of said Lot 8 of Gibbon's Subdivision, said iron pin set being also the **TRUE POINT OF BEGINNING**, of the parcel herein described;

thence along the south right-of-way line of Charles street South 32 degrees 56 minutes 19 seconds East, a distance of 5.00 feet to an iron pin set (Eicher);

thence leaving said right-of-way line South 32 degrees 37 minutes 07 seconds West, a distance of 33.54 feet, to an iron pipe found, said pipe being on the west line of said Lot 8 of Gibbon's Subdivision and the Northeast corner of lands conveyed to Randall E. Kerr, D.V. 1105, Pg. 646;

thence along said west line of lot 8 of Gibbon's Subdivision and the west right-of-way line of a 10' alley North 25 degrees 20 minutes 00 seconds East, a distance of 35.90 to an iron pin set (Eicher) being also the true point of beginning, containing 0.002 acre more or less.

The bearings in the above description are based on the West line of Lot 8 of Gibbon's Subdivision, Plat Book 2, Page 58, being North 25 degrees 20 minutes 00 seconds East.

Iron pins set are 5/8" rebar, 30" long with plastic ID caps Eicher S-8233.

Subject to all right of ways, easements, restrictions, zoning regulations, either written or implied.

Not to be used as a separate building site or transferred as an independent parcel in the future without planning commission approval in accordance with applicable subdivision regulations. Parcel to be combined to Auditor's Parcel Number 84-09-02-22-000.

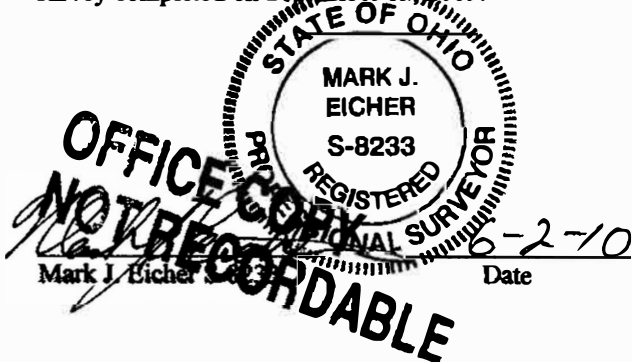

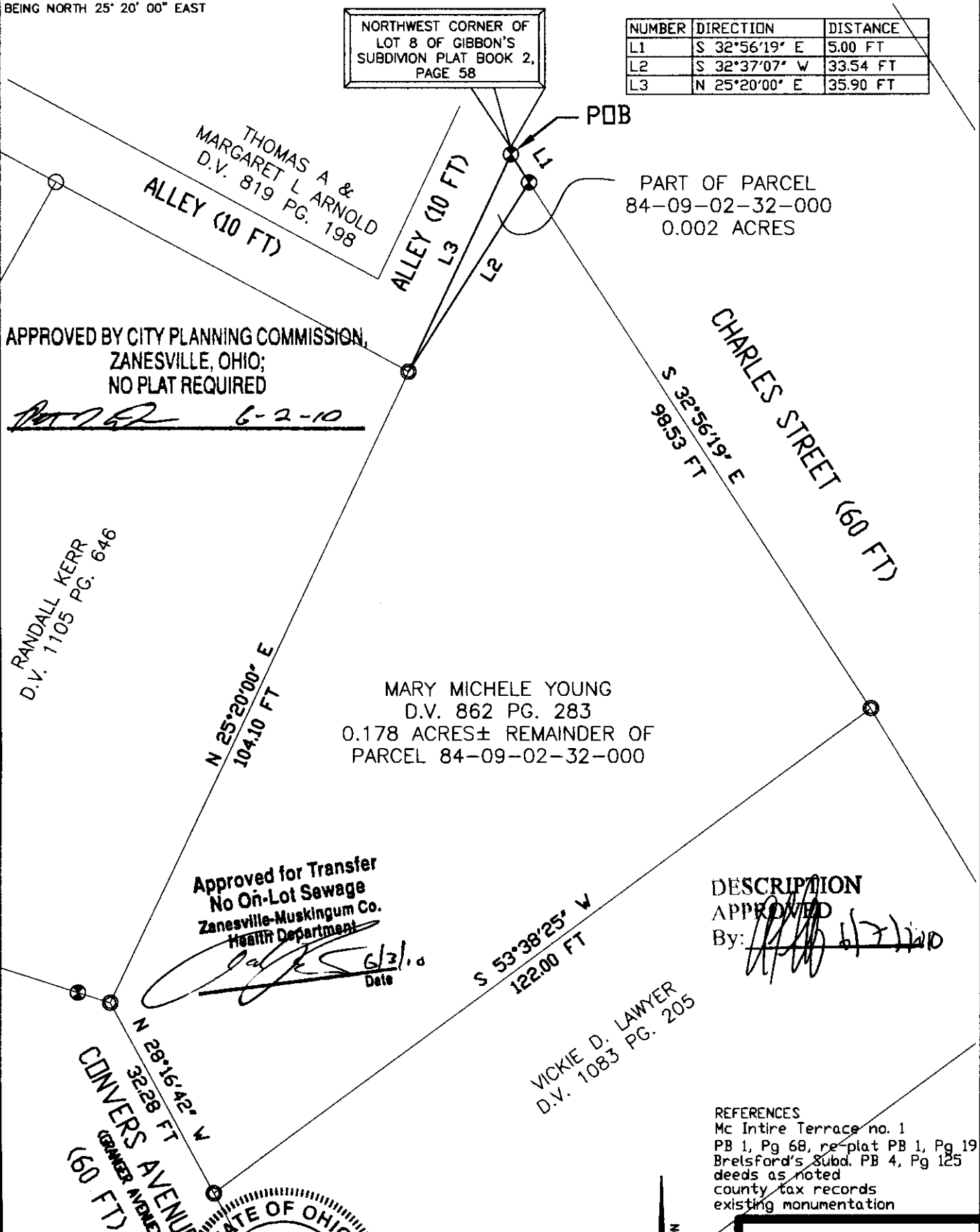

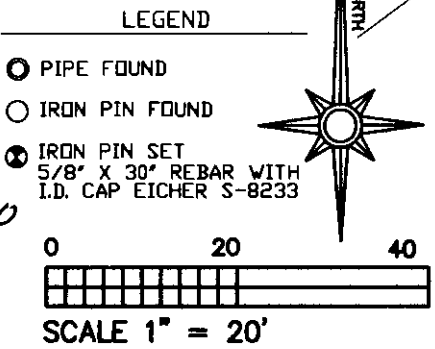
