SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF LOT #14 OF MOUNT AUBURN ADDITION, AS RECORDED IN PLAT BOOK 1, PAGES 74 AND 75, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1120, PAGE 74; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT #14, THENCE, NORTH 59 DEGREES - 57 MINUTES - 18 SECONDS WEST, 102.60 FEET TO A STONE FOUND ON THE WESTERLY SIDE OF AN ALLEY; THENCE, CONTINUING NORTH 59 DEGREES - 57 MINUTES - 18 SECONDS WEST, 209.86 FEET TO AN IRON PIN FOUND; THENCE, NORTH 30 DEGREES - 36 MINUTES - 00 SECONDS EAST, 105.00 FEET TO AN IRON PIN SET; THENCE, CONTINUING NORTH 30 DEGREES - 36 MINUTES - 00 SECONDS EAST, 105.00 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE, CONTINUING NORTH 30 DEGREES - 36 MINUTES - 00 SECONDS EAST, 71.30 FEET TO AN AXLE FOUND ON THE SOUTH LINE OF ROOSEVELT AVENUE;

THENCE, ALONG SAID STREET, SOUTH 86 DEGREES - 47 MINUTES - 04 SECONDS EAST, 35.00 FEET TO AN IRON PIN FOUND;

THENCE, NORTH 76 DEGREES - 57 MINUTES - 56 SECONDS EAST, 193.30 FEET TO AN IRON PIN FOUND;

THENCE, SOUTH 58 DEGREES - 02 MINUTES - 04 SECONDS EAST, 48.40 FEET TO AN IRON PIN FOUND;

THENCE, LEAVING SAID ROOSEVELT AVENUE, SOUTH 31 DEGREES - 52 MINUTES - 30 SECONDS WEST, 217.71 FEET ALONG THE WESTERLY LINE OF SAID ALLEY TO AN IRON PIN SET;

THENCE, NORTH 59 DEGREES - 55 MINUTES - 45 SECONDS WEST, 214.53 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.7789 ACRES MORE OR LESS.

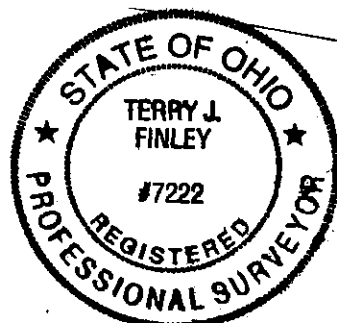
