**BEGINNING** AT A POINT AT THE SOUTHEAST CORNER OF LOT 26 OF McINTIRE TERRACE #1 (PLAT BOOK 1, PAGE 68);

**THENCE** WITH THE SOUTH LINE OF LOT 26 OF McINTIRE TERRACE #1 AND THE NORTH LINE OF McINTIRE AVENUE, NORTH 62 DEGREES 50 MINUTES 00 SECONDS WEST 62.17 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 2.00 FEET;

**THENCE** LEAVING THE SOUTH LINE OF SAID LOT 26 AND TRAVERSING THROUGH A TRACT CONVEYED TO L. AND S. KIMBLE (VOLUME 605, PAGE 44), NORTH 28 DEGREES 31 MINUTES 17 SECONDS EAST 66.18 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF A TRACT CONVEYED TO C. AND M. CLARK (VOLUME 827, PAGE 207);

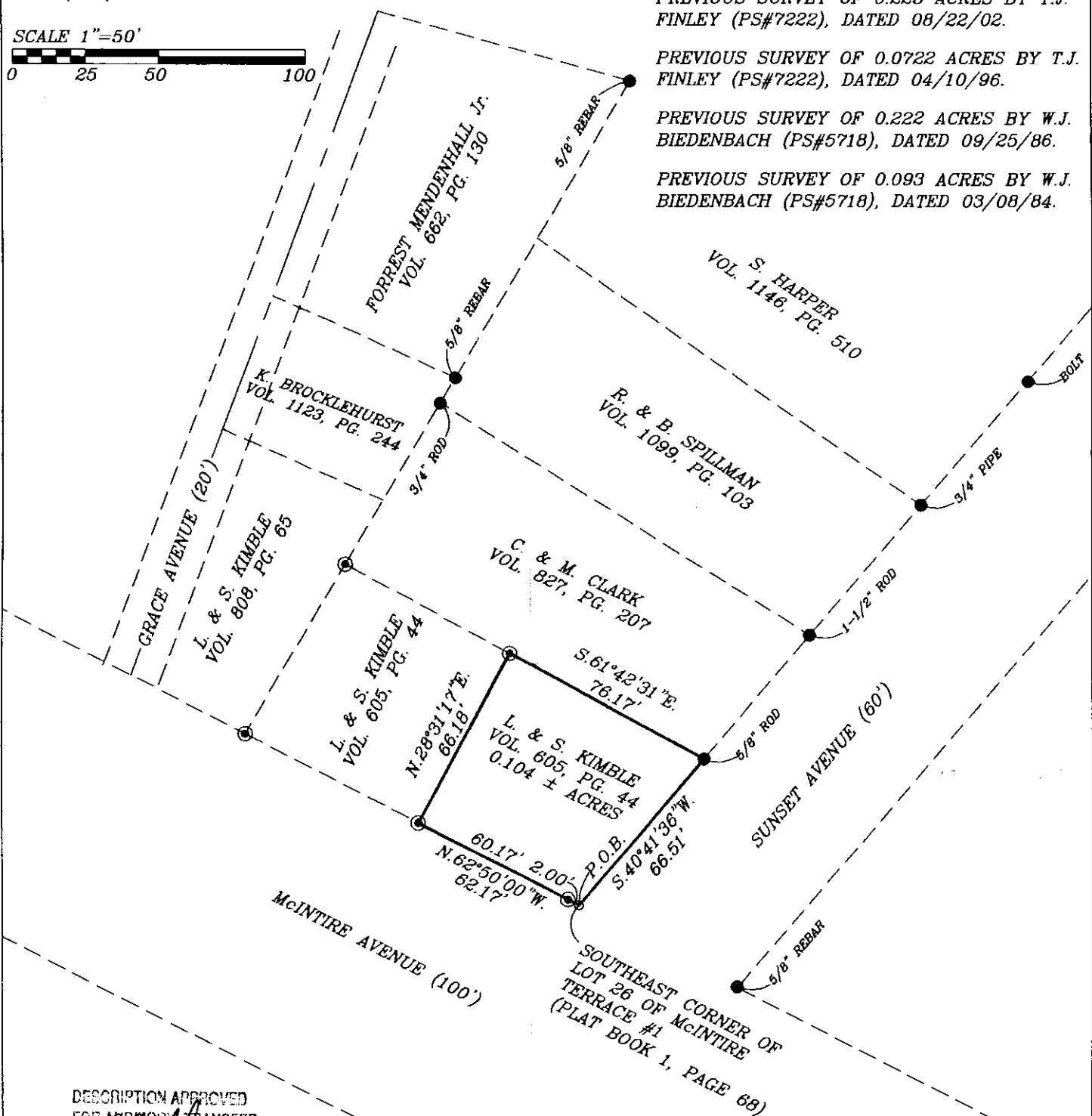
