SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING A PART OF LOTS #5 AND #4 OF AN UNRECORDED SUBDIVISION OF LOT #43 IN THE McINTIRE TERRACE 2, AS RECORDED IN PLAT BOOK 1, PAGE 157. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT AT THE SOUTHWEST CORNER OF LOT #44 OF SAID McINTIRE TERRACE PLAT 2, SAID POINT ALSO BEING THE INTERSECTION OF THE EAST LINE OF MAPLE AVENUE AND THE NORTH LINE OF McINTIRE AVENUE; THENCE, NORTH 01 DEGREES - 40 MINUTES - 00 SECONDS EAST, 319.87 FEET TO AN "X" SCRIBED IN A CONCRETE SIDEWALK AT THE SOUTHWEST CORNER OF THE PROPERTY HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 01 DEGREES - 40 MINUTES - 00 SECONDS EAST, 44.00 FEET TO AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THOSE LANDS DESCRIBED IN DEED VOLUME 889, PAGE 292; THENCE, SOUTH 83 DEGREES - 03 MINUTES - 49 SECONDS EAST, 155.01 FEET TO AN IRON PIN FOUND IN A TWELVE FOOT ASPHALT ALLEY; THENCE, SOUTH 27 DEGREES - 30 MINUTES - 51 SECONDS WEST, 46.80 FEET TO A RAILROAD SPIKE SET; THENCE, NORTH 83 DEGREES - 03 MINUTES - 49 SECONDS WEST, 134.52 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.146 ACRES MORE OR LESS.

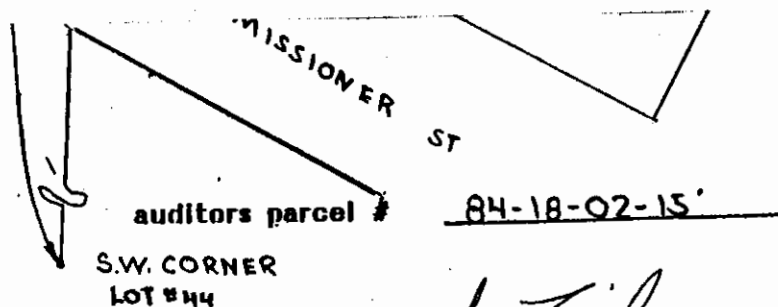

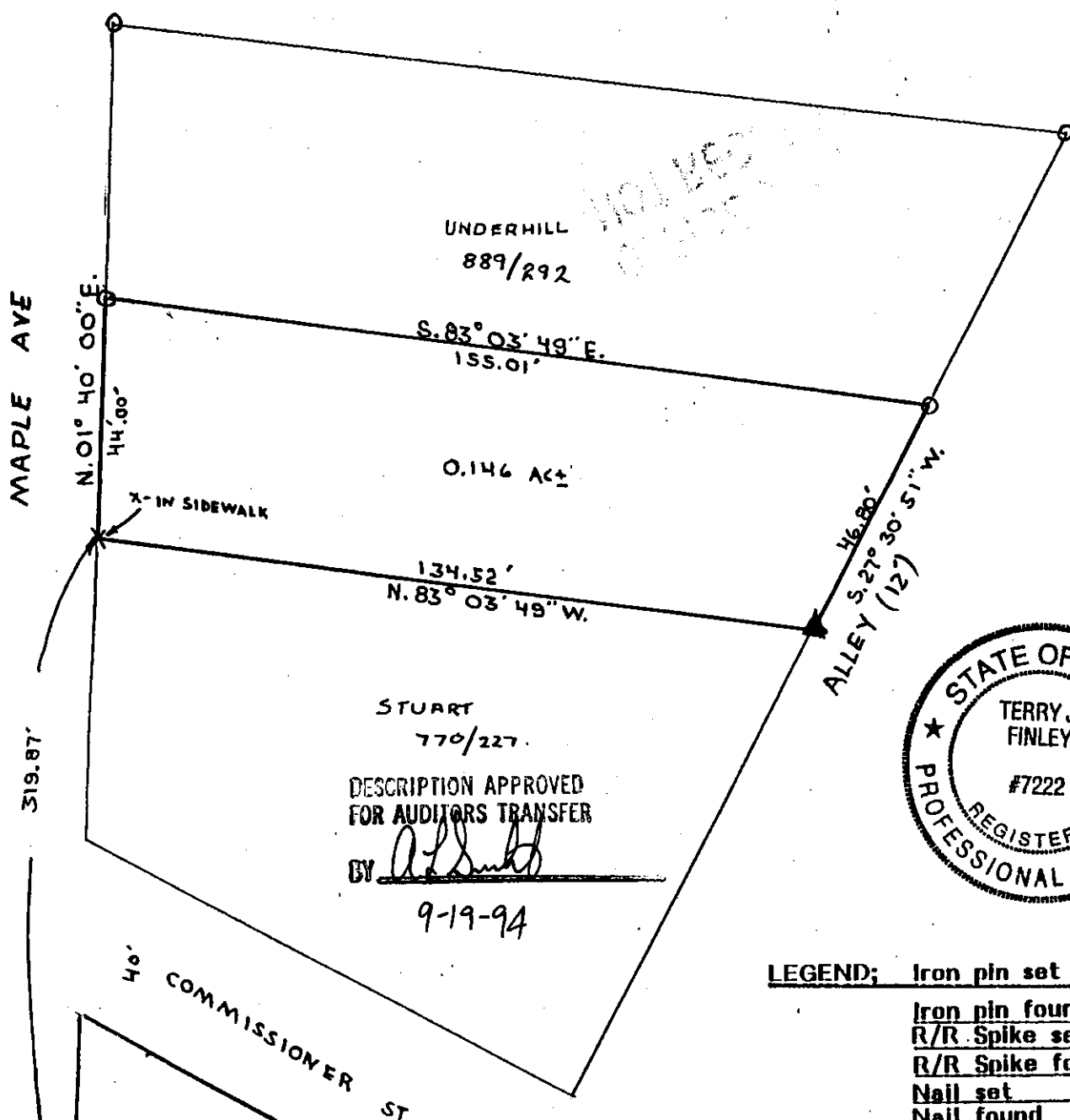
