Being part of Lots 15 and 16, Square 10 of Town (now City) of Zanesville as the same is designated and delineated on Muskingum County Deed Book E, Page 444; beginning for reference at the southeast corner of said Lot 16; thence with the west line of Fourth Street North 00 degrees 00 minutes 00 seconds East 58.50 feet to the principal place of beginning; thence North 89 degrees 42 minutes 58 seconds West 77.27 feet to a railroad spike set; thence North 00 degrees 00 minutes 00 seconds East 38.50 feet to a railroad spike set, passing the south line of said Lot 15 at 7.5 feet; thence North 89 degrees 42 minutes 58 seconds West 54.73 feet to a railroad spike set on the west line of said Lot 15; thence with said west line North 00 degrees 00 minutes 00 seconds East 35.00 feet to a railroad spike set on the north line of said Lot 15; thence with said north line South 89 degrees 42 minutes 58 seconds East 132.00 feet to a railroad spike set on the northeast corner of said lot and the west line of Fourth Street; thence with the west line of Fourth Street South 00 degrees 00 minutes 00 seconds West 73.50 feet to the principal place of beginning, passing the south line of Lot 15 at 66.00 feet, containing 0.17 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the west line of Fourth Street as bearing North 00 degrees 00 minutes 00 seconds East.

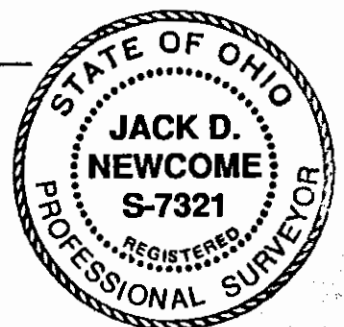

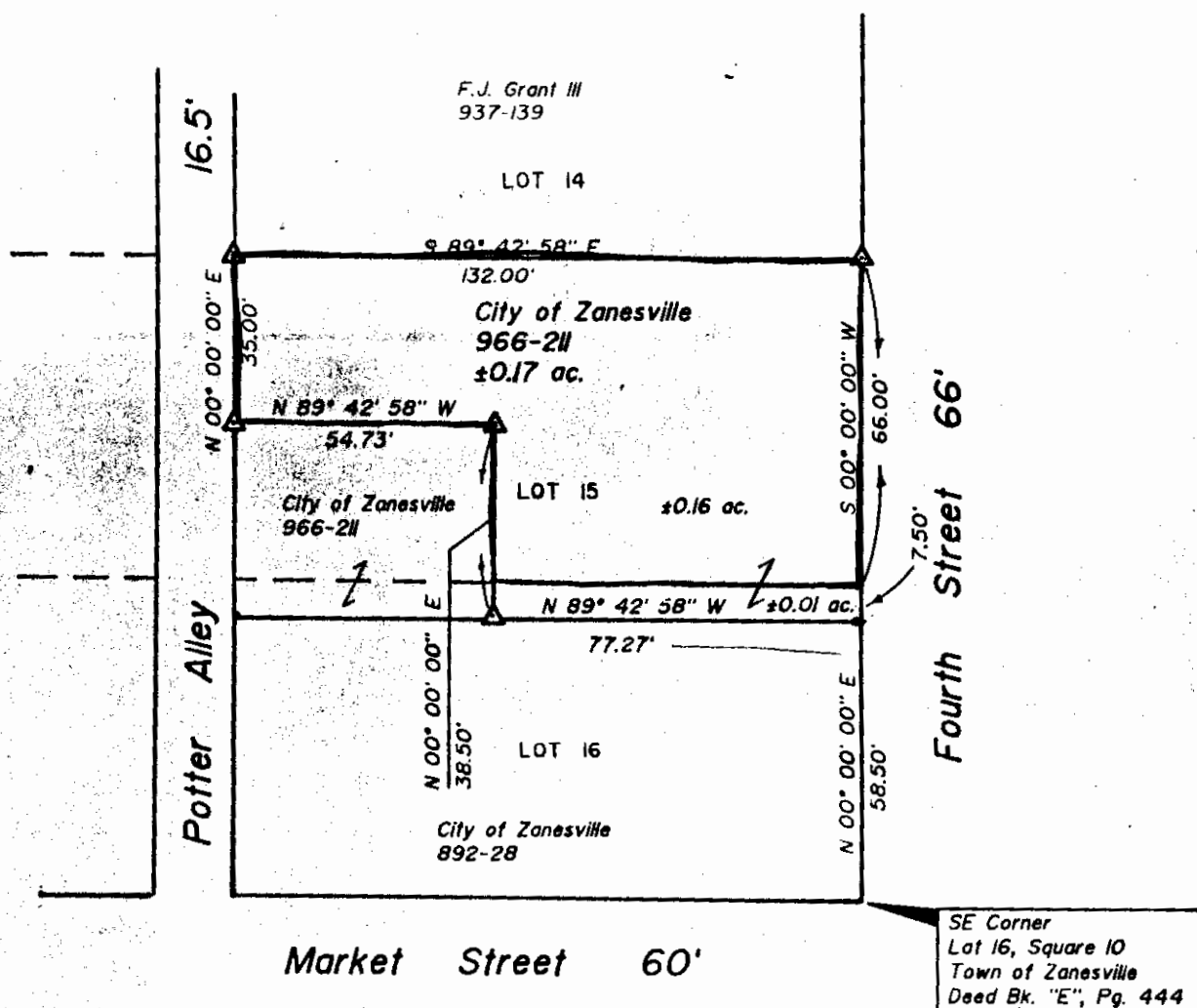
