Commencing at the intersection of the West line of Glessner Street and the South line of Greenwood Avenue; thence South $82^{\circ} 19' 54''$ West 131.97 feet to an iron pin set on the West line of a 10.00 foot alley and the South line of Greenwood Avenue; thence along the West line of 10.00 foot alley South $5^{\circ} 15'$ West 117.82 feet to an iron pin set; thence leaving said alley North $89^{\circ} 10' 46''$ West 49.59 feet to an iron pin set on the East line of a 7.00 foot wide walk way; thence along East line of walk way North $5^{\circ} 03' 01''$ East 117.81 feet to an iron pin set on South line of Greenwood Avenue; thence along Greenwood Avenue South $89^{\circ} 09'$ East 50.00 feet to the place of beginning, containing 0.135 acres more or less.

Commencing at the intersection of the West line of Glessner Street and the South line of Greenwood Avenue; thence South $82^{\circ} 19' 54''$ West 131.97 feet to the intersection of the West line of 10.00 foot alley and the South line of Greenwood Avenue; thence along the West line of said alley South $5^{\circ} 15'$ West 117.82 feet to an iron pin set, the place of beginning; thence South $5^{\circ} 15'$ West 39.28 feet; thence leaving said alley South $88^{\circ} 54' 00''$ West 11.98 feet to an iron pin set; thence North $5^{\circ} 15'$ East 21.22 feet to an iron pin set; thence North $36^{\circ} 50' 05''$ East 22.75 feet to the place of beginning, containing 0.008 acres more or less.

Bearings are based on 10.00 foot alley bearing South $5^{\circ} 15'$ West.

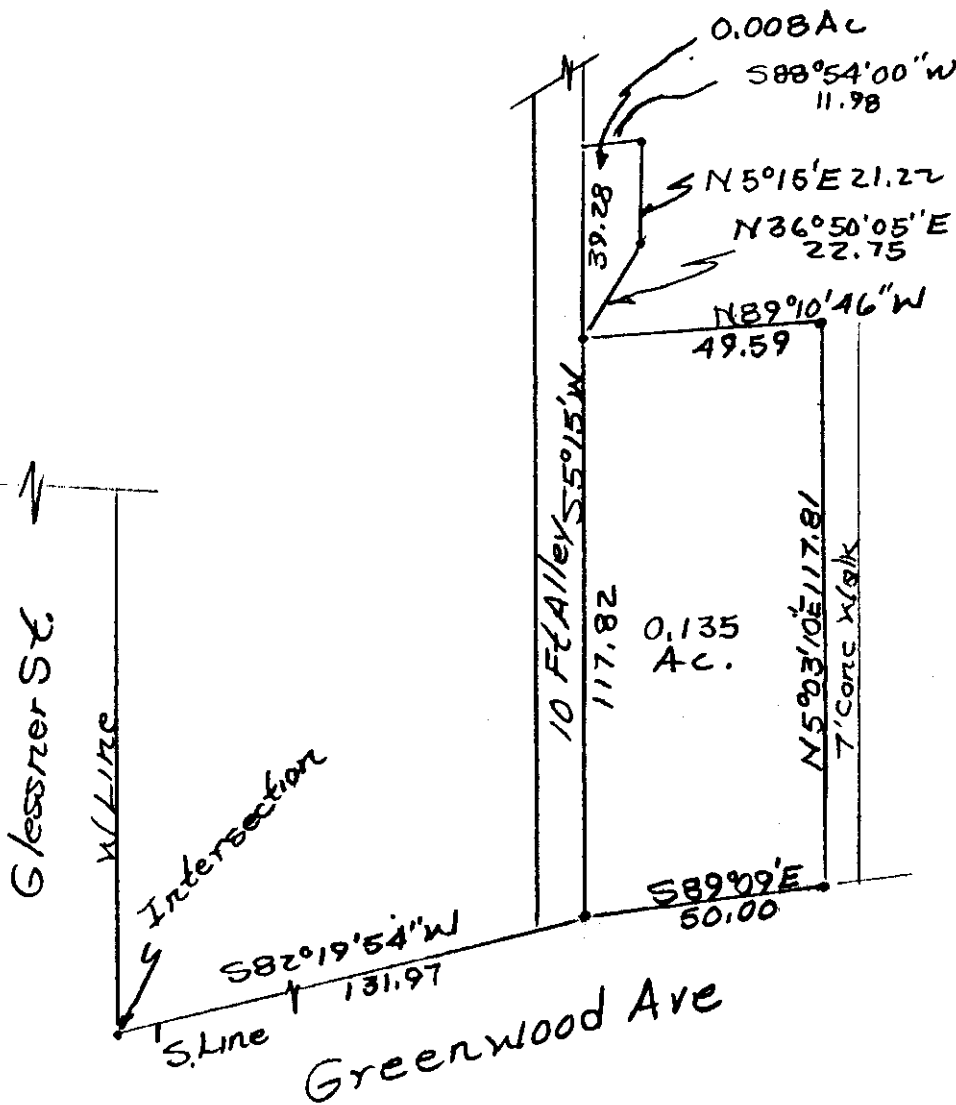
