## DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, City of Zanesville, being a resurvey of Smith V 637 P 186, and more particularly described as follows:

Beginning at an iron pin found at the Southwest Corner of Lot 22 in Elmwood Place Plat, Book 5 page 31; thence along the North line of Wheeling Ave. North 83 Degrees 29 Minutes 00 Seconds West 56.00 feet to an iron pin found and the place of beginning; thence continuing along said line North 83 Degrees 29 Minutes 00 Seconds West 54.50 feet to a 5/8 inch hole set in concrete, passing the west line of a 8.00 feet easement at 8.05 feet; thence leaving Wheeling Ave. North 00 Degrees 00 Minutes 00 Seconds West 120.00 feet to an iron pin set; thence South 83 Degrees 29 Minutes 00 Seconds East 54.50 feet to an iron pin set, passing the West line of a 8.00 feet easement at 46.45 feet; thence along the East line of this described tract and 8.00 feet easement South 00 Degrees 00 Minutes 00 Seconds East 120.00 feet to the place of beginning, containing 0.15 acres, more or less, total, being 0.02 acres of easement for ingress and egress, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the North line of Wheeling Ave. as being North 83 Degrees 29 Minutes 00 Seconds West.

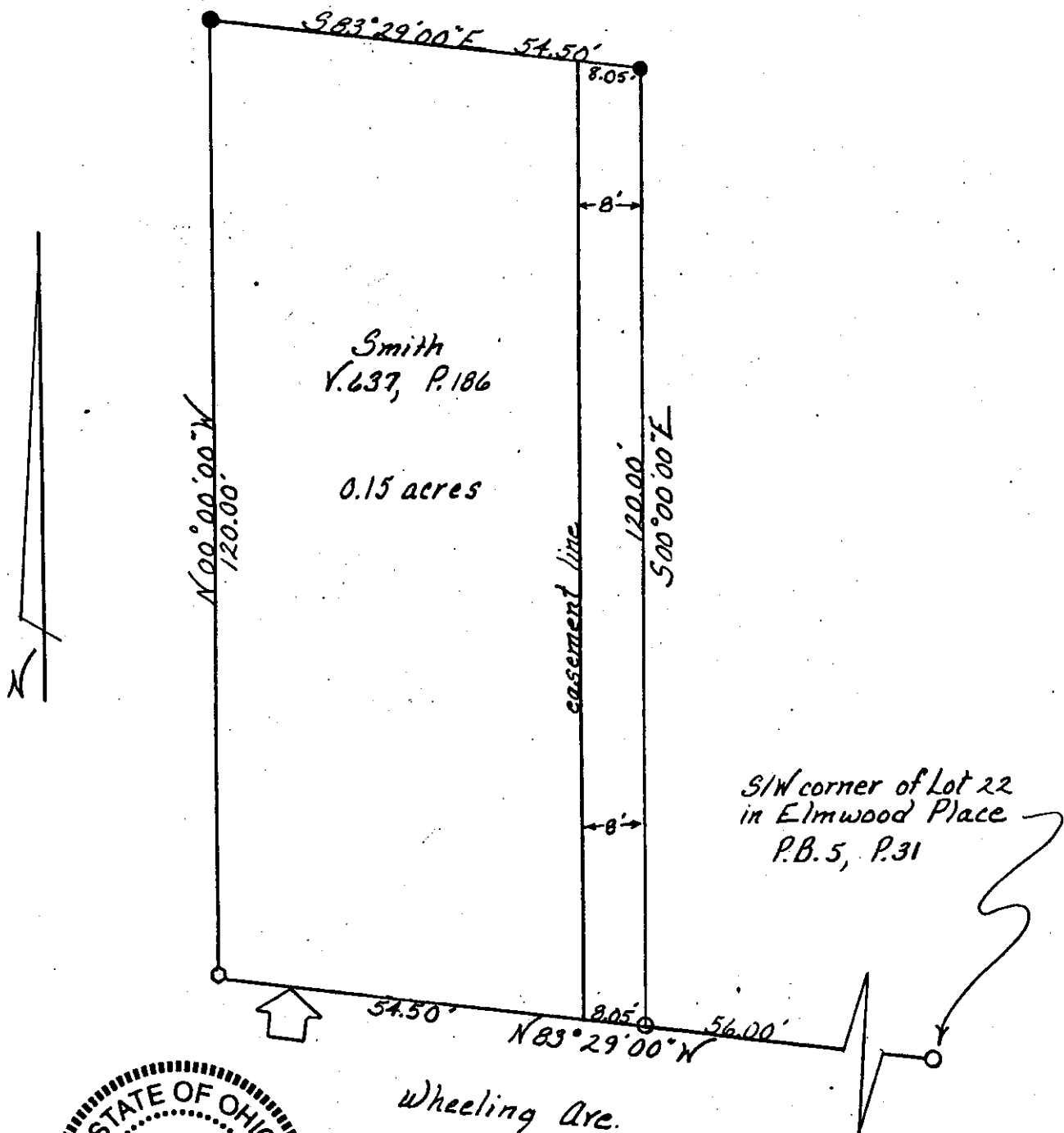
