COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT 25, SAID POINT ALSO BEING THE INTERSECTION OF THE WEST LINE OF FOX AVENUE AND THE NORTH LINE OF EASTMAN STREET; THENCE, SOUTH 88 DEGREES - 00 MINUTES - 19 SECONDS WEST, 39.00 FEET TO A POINT ON THE NORTH LINE OF SAID EASTMAN STREET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING SOUTH 88 DEGREES - 00 MINUTES - 19 SECONDS WEST, 40.00 FEET TO AN IRON PIN FOUND; THENCE, LEAVING EASTMAN STREET, NORTH 02 DEGREES - 22 MINUTES - 36 SECONDS WEST, 129.00 FEET TO A POINT ON THE NORTH LINE OF LOT #24, PASSING THE NORTH LINE OF LOT #25 AT 60.00 FEET; THENCE, NORTH 88 DEGREES - 00 MINUTES - 19 SECONDS EAST, 40.00 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 24; THENCE, SOUTH 02 DEGREES - 22 MINUTES - 36 SECONDS EAST, 129.00 FEET TO THE POINT OF BEGINNING, PASSING THE NORTH LINE OF LOT #25 AT 69.00 FEET, AND CONTAINING 0.119 ACRES MORE OR LESS.

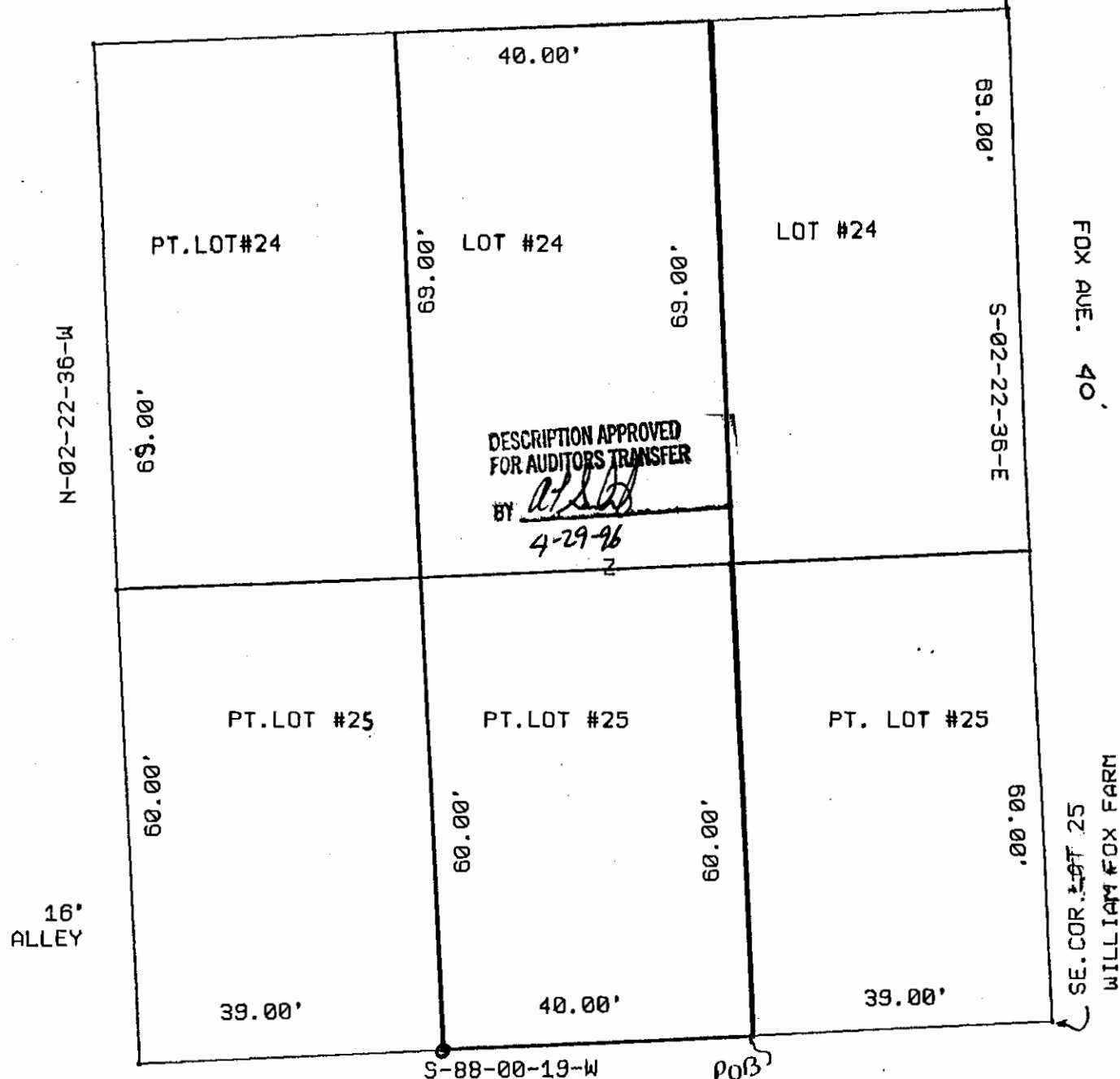

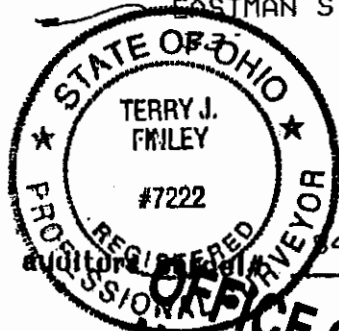
