COMMENCING AT THE INTERSECTION OF THE SOUTH LINE OF EASTMAN STREET AND THE EAST LINE OF BEULAH AVENUE; THENCE, SOUTH 07 DEGREES - 10 MINUTES - 00 SECONDS WEST, 199.75 FEET TO A POINT ON THE EAST LINE OF SAID BEULAH AVENUE AND THE TRUE PLACE OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, SOUTH 85 DEGREES - 30 MINUTES - 00 SECONDS EAST, 69.74 FEET TO AN IRON PIN SET ON THE WESTERLY LINE OF AN ALLEY; THENCE, SOUTH 03 DEGREES - 56 MINUTES - 05 SECONDS WEST, 32.16 FEET TO AN IRON PIN FOUND; THENCE, NORTH 85 DEGREES - 30 MINUTES - 00 SECONDS WEST, 71.55 FEET TO A HOLE DRILLED IN A RETAINING WALL ON THE EAST LINE OF BEULAH AVENUE; THENCE, NORTH 07 DEGREES - 10 MINUTES - 00 SECONDS EAST, 32.19 FEET TO THE PLACE OF BEGINNING AND CONTAINING 0.052 ACRES MORE OR LESS.
