Situated in the State of Ohio, County of Muskingum, City of Zanesville:
 Being a part of Quarter Township Three (3), Township One (1), Range Seven
 (7) of the United States Military Lands formerly in Washington Township now in the
 City of Zanesville and property now in the name of Frank and Jane Hastings and
 Recorded in Deed Book 993, Page 225 and Deed Book 1036, Pg. 601 of the Muskingum
 County Deed Records bounded and described as follows:

Beginning at a 1 1/2" solid iron pin found at the northwest corner of Lot 10 in Cox
 Addition to the City of Zanesville and Recorded in Plat Book 1, Page 262 of the Plat
 Records in said Muskingum County; thence N88°48'32"W (the base of bearings for this
 description is true north by an observation of the sun) along the south line of a 0.362 acre
 parcel (Land Contract Vol. 1109, Pg. 631) and along the north line of said Lot 11 and the
 north line of property owned by Steve and Cora Hartman (Vol. 1658, Pg. 156) a
 distance of 183.19 feet to an iron pin found on the east line of a 0.13 acre parcel owned
 by the grantor herein (Vol. 1036, Pg. 601); thence S 3°40'07" W along the east line of
 said 0.13 acre parcel and the west line of said Lot 11 in Cox addition 15.00 feet to an iron
 pin found; thence S 78°05'56"W along the south line of said 0.13 acre parcel 43.14 feet
 to an iron pin found on the east line of Devin Street; thence N 38°10'02"W along the
 easterly line of said street 68.10 feet to a point that intersects with the southerly line of
 Nutt Street; thence N 60°06'56"E along the southerly line of said street 224.12 feet to an
 iron pin set and passing through an iron pin found at 10.00 feet and through an iron pin
 found at the northeast corner of the aforesaid 0.13 acre parcel at 104.37 feet and through
 an iron pin found at 206.14 feet at the Northeast corner of a 0.362 acre parcel (Land
 Contract Vol. 1109, Pg. 631); thence through the lands of the grantor herein (Vol. 993,
 Pg. 225) and along the east line of a 0.720 acre parcel to be added to the Land Contract
 in Vol. 1109, Pg. 631 the following 2 courses and distances:

- 1- S 47°03'57"E 60.20 feet to an iron pin set
- 2- S 16°04'35"E 108.37 feet to the place of beginning containing five hundred sixty four
 thousands (0.564) of an acre.

0.13 acre is all of parcel No. 84-46-01-04-002.

0.362 acre parcel and 0.072 acre parcel part of Parcel No. 84-46-01-02-000.

Subject to all legal right of ways and easements on record.

All iron pins set are 5/8"x 30" rebar capped Graves No. 5792.
