Beginning at an iron pin (set) at the Northeast corner of said Lot #12; thence along the East line of said lot and the West line of Freeborn Avenue S 03 28 27 W 50.00 feet to the Northeast corner of the property described in deed reference Volume 889, Page 209; thence along the North line of said Volume 889, Page 209 N 86 33 20 W 88.00 feet to an iron pin (set) on the East line of the property described in deed reference Volume 984, Page 37, passing an iron pin (found) at 1.00 feet; thence along the East line of said Volume 984, Page 37 N 03 28 27 E 50.00 feet to the South line of an alley, passing an iron pin (set) at 45.00 feet; thence along the South line of said alley S 86 33 20 E 88.00 feet to the place of beginning containing 0.101 acres.

The bearings within this description are based on a Solar Observation (local Hour Angle Method) completed within Lot #12. Iron pins (set) are 5/8" rebar with aluminum identification caps (C.R. Harkness R.S. 6885).

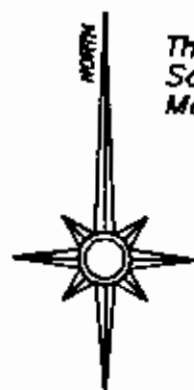

PLAT #01



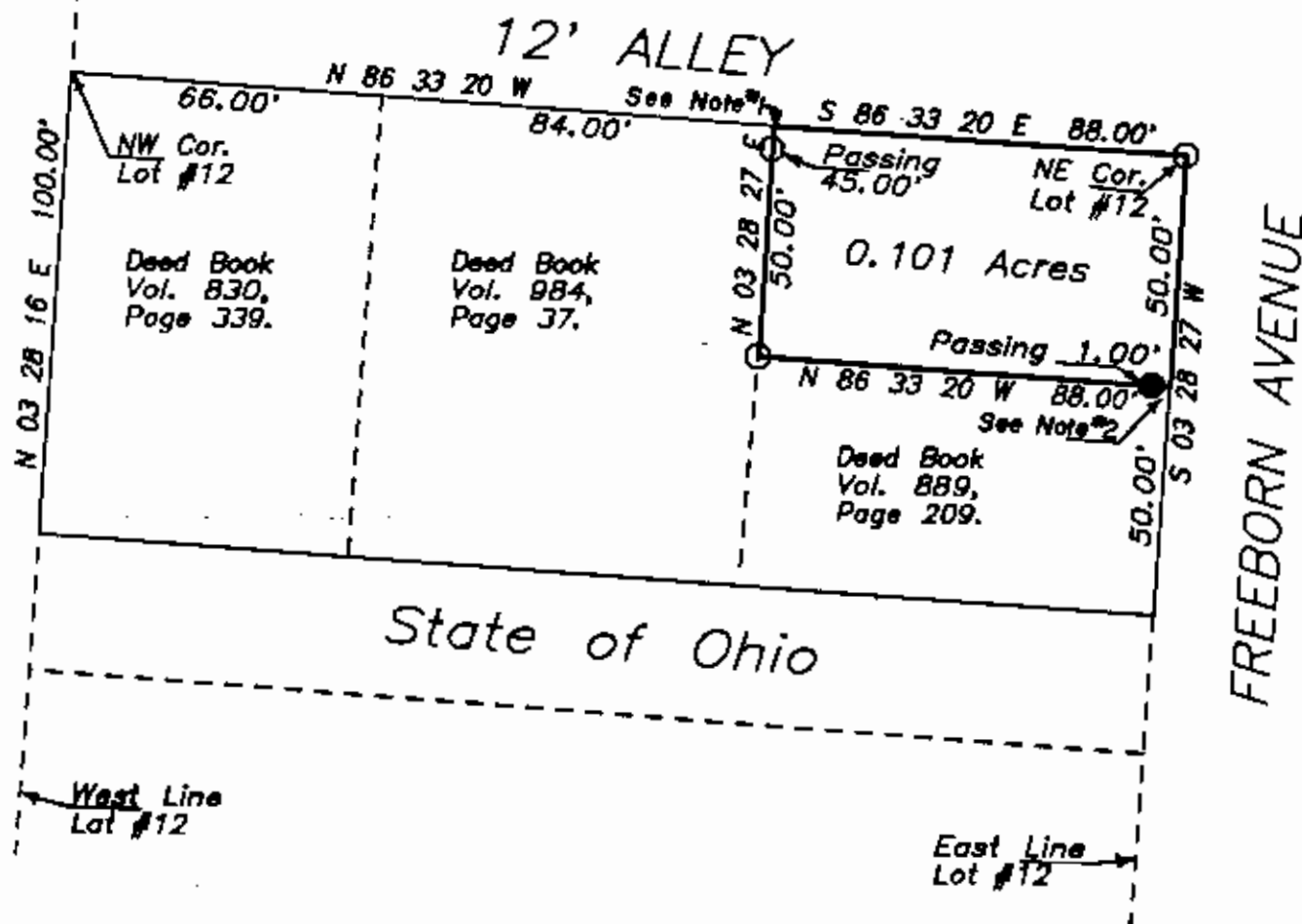
The bearings on this plat are based on a Solar Observation (Local Hour Angle Method), completed within Lat #12.
