Situated in the City of Zanesville, Muskingum County, Ohio. Being part of lot #36 of Park Place Addition as recorded in Plat Book 2 page 37 of the Muskingum County Plat records and being more particularly described as follows:

Beginning at an iron pin set in the Southwest corner lot #36; thence, N.25° 04'00"E. a distance of 37.35 feet along the easterly line of a 16 foot ally to a set iron pin on the Southwest corner of B. & C. Kissinger (928/339); thence, S.64°56'00"E. a distance of 35.30 feet along the South line of said Kissinger lands to a set iron pin; thence, S.25° 04'00"W. a distance of 37.35 feet through the lands of Thelma Clark (409/343) to a set iron pin on the North line of a 16 foot Alley; thence, N.64°56'00"W. a distance of 35.30 feet along the North line of said alley to the point of beginning.

The above described parcel contains 1,318.46 Square Feet, more or less, and is subject to all legal easements and right of ways. North is based upon record bearings as recorded in plat book 2 page 37. All set iron pins are 3/4" x 30" pins with I.D. caps.

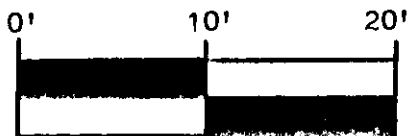
