Buckeye Supply property description for the north part of Parcel "F" within the "Underwood Urban Renewal" City of Zanesville, Muskingum County, Ohio described as follows:

Commencing at a monument at the centerlines intersect of Zane Street and Monroe Street;

thence south $20^{\circ} 22' 14''$ west, 40.00 feet along the centerline of Monroe Street to a point;

thence north $87^{\circ} 27' 34''$ west, 25.00 feet to a point being the intersection of the southerly right of way line of Zane Street and the westerly right of way line of Monroe Street, said point being the true point of beginning of the Parcel "F" boundary survey;

thence south $20^{\circ} 22' 14''$ west, 295.10 feet along the westerly right of way line of Monroe Street to a point;

thence north $87^{\circ} 37' 46''$ west, 241.66 feet to a point on the easterly right of way line of Underwood Street (S.R. 60);

thence north $60^{\circ} 47' 47''$ east, 281.62 feet along the easterly right of way line of Underwood Street to a point on the southerly right of way line of Zane Street;

thence north $49^{\circ} 55' 03''$ east, 22.05 feet along the southerly right of way line of Zane Street to a point on said right of way line;

thence south $87^{\circ} 27' 34''$ east, 203.80 feet along the southerly right of way line of Zane Street to a point being the intersection of the southerly right of way line of Zane Street and the westerly right of way line of Monroe Street and also being the true point of beginning, containing 1.559 acres, more or less (67,910.04 square feet).

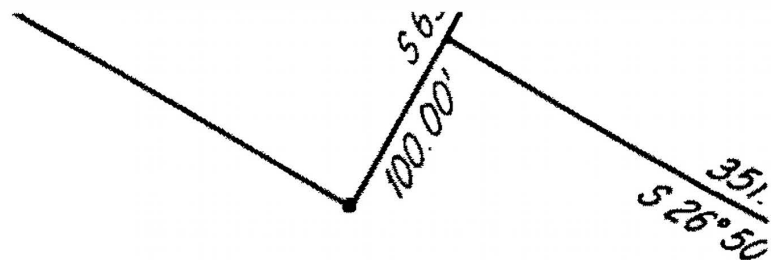

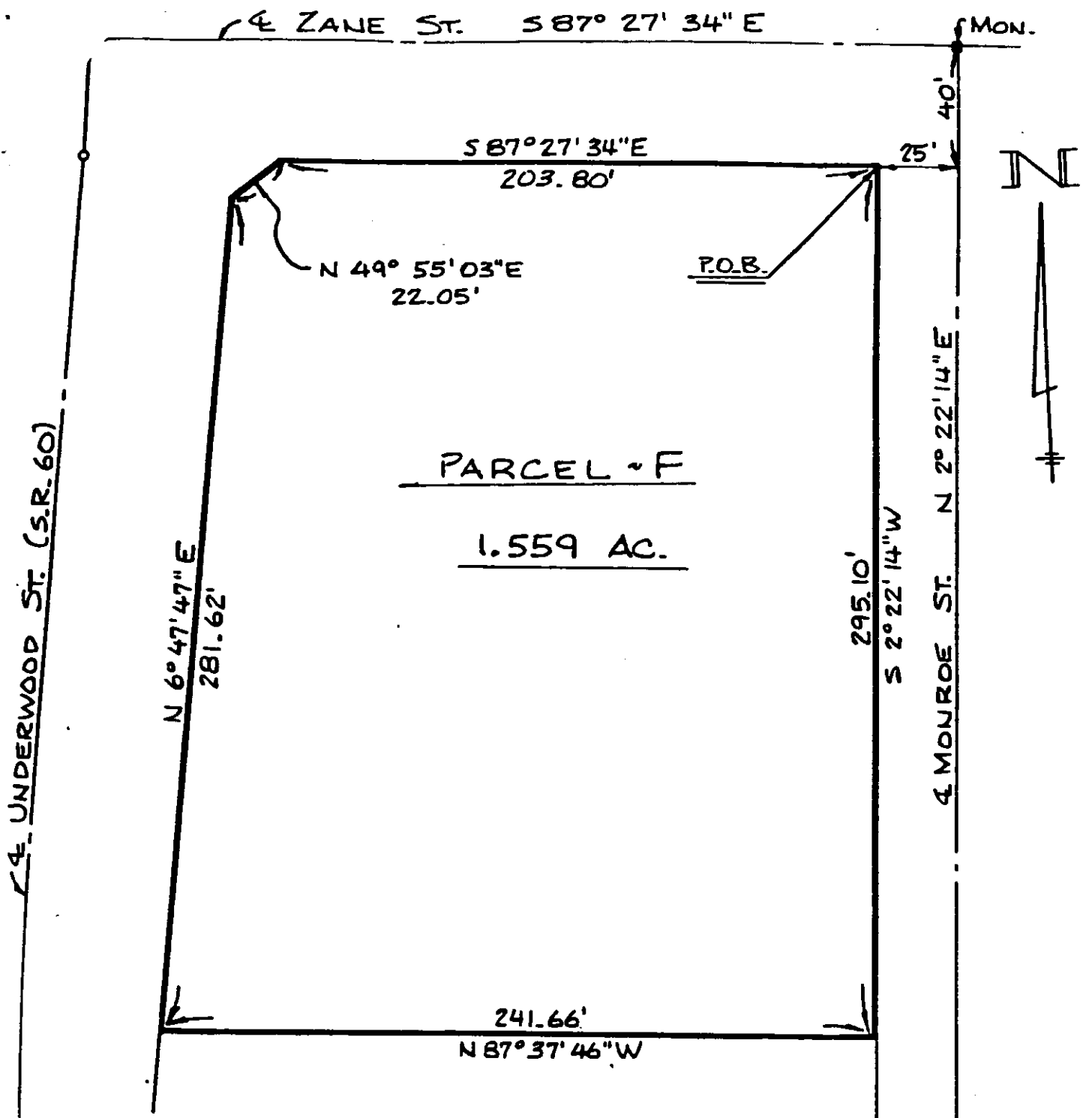
