Situated in the State of Ohio, County of Muskingum,  
Township of Washington, NOW in the City of Zanesville.

Being a part of Lot 16 of James Moore Survey by Charles Roberts as on file in the County Engineer's Office of Muskingum County, Ohio, a subdivision of a part of the Third Quarter, Township 1, Range 7 bounded and described as follows:

Commencing at the southeast corner of Lot 16 of said subdivision in the center of State Route 40; thence North 2 degrees 56 minutes 39 seconds West 42.84 feet to an iron pin on the north right of way line of State Route 40; thence along said right of way line South 66 degrees 04 minutes 21 seconds West 74.98 feet to a point on the east line of a 0.19 acre parcel conveyed to ABI Phone Systems, Inc. by deed recorded in Deed Book 1003, Page 282; thence along said 0.19 acre parcel the following two (2) courses and distances North 27 degrees 40 minutes 36 seconds West 125 feet to an iron pin; thence South 66 degrees 04 minutes 21 seconds West 50 feet to an iron pin; thence North 27 degrees 40 minutes 36 seconds West 76.04 feet to an iron pin found at the northeast corner of property owned by Century National Bank, Deed Book 2518, Page 318 and the true place of beginning of the premises herein intended to be described; thence along the north line of said Bank property south 81 degrees 48 minutes 33 seconds west 107.59 feet to an iron pin found; thence south 60 degrees 26 minutes 28 seconds west 71.35 feet to an iron pin placed; thence south 83 degrees 30 minutes 42 seconds west 212.83 feet to an iron pin placed on the east line of a 26 foot right of way as described in Deed Book 1155, Page 695; thence along said right of way north 14 degrees 52 minutes 59 seconds east 220.69 feet to an iron pin placed; thence north 81 degrees 44 minutes 38 seconds east 347.86 feet to an iron pin placed passing the northwest corner of a concrete block building at 180.86 feet and passing the northeast corner of said building at 330.86 feet; thence south 8 degrees 15 minutes 22 seconds east 183.76 feet to an iron pin placed; thence south 81 degrees 48 minutes 33 seconds west 47.79 feet to the true place of beginning, containing one and seventy-six hundredths (1.76) acres more or less.

Easement "A"

There is also hereby conveyed to the Grantee herein an easement for ingress and egress between the above described 1.76 Acres and State Route 40 to be used in common with others over and across property owned by the Grantor herein Deed Book 2398, Page 282 described as follows:

Commencing at an iron pin placed at the northwest corner of the above described 1.76 acres; thence south 81 degrees 44 minutes 38 seconds west 14.14 feet to the centerline of this easement and the true place of beginning; thence along the center of said easement being a strip of ground 26 feet wide and 13 feet on each side of the following described line

south 14 degrees 52 minutes  
59 seconds west 216.02 feet to a point where said easement  
forms a "Y" and begins to taper towards each branch; thence  
along the west branch of said easement south 21 degrees  
21 minutes 01 seconds west 99.67 feet to a point where said  
taper ends and the easement is 7.50 feet on each side of  
the centerline to the terminus; thence on a curve to the  
left having a radius of 260.00 feet, an arc length of 193.58  
feet and a chord bearing south 01 degrees 23 minutes 43  
seconds east a distance of 187.15 feet to a point; thence  
south 21 degrees 18 minutes 27 seconds east 95.62 feet to  
the north right of State Route 40 and the terminus of said  
branch of easement; thence along the east branch of said  
easement from the point of "Y" south 07 degrees 05 minutes  
45 seconds west 103.11 feet to a point where said taper  
ends and easement is 7.50 feet on each side of the centerline

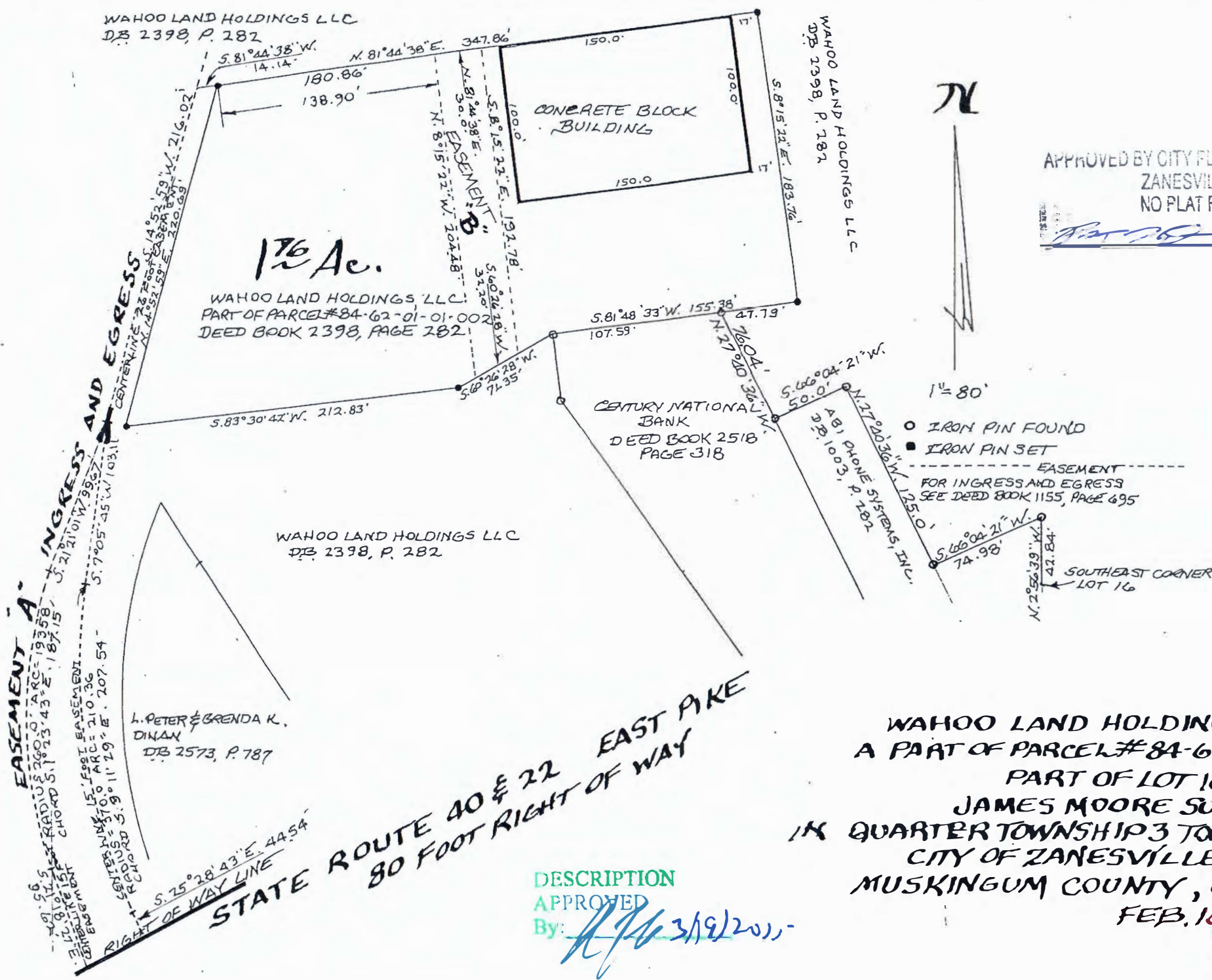
