> SURVEY DESCRIPTION FOR WILBUR EMMERT ESTATE

Situated in the City of Zanesville, Muskingum, County, Ohio. Being part of LOts #2 and #3 of Square #5 in Taylors Second Addition (P.B.2 Pg. 4 & 5) as conveyed to Wilbur Emmert in Deed Book 1045 page 078 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at the Southwest corner of Lot #1 of Square #5; thence, N.22<sup> $\circ$ </sup> 15<sup>2</sup>8"E. a distance of 186.36 feet along the East line of an alley to a found iron pin on the Southwesterly corner of the lands (now or formerly) owned D. Moore (810/303), BEING THE POINT OF BEGINNING; thence, S.78<sup> $\circ$ </sup>58<sup> $\cdot$ </sup>15"E. a distance of 159.47 feet along the North line of said Moore lands (810/303) to a found iron pin on the West line of Linden Ave.; thence, N.25<sup> $\circ$ </sup>03<sup> $\cdot$ </sup>05"E. a distance of 84.39 feet along said West line to a found iron pin on the South East corner of the lands (now or formerly) owned by C. Micheli (226/259); thence, N.79<sup> $\circ$ </sup>20<sup> $\cdot$ </sup>28"W. a distance of 61.98 feet along the South line of said Micheli to a found iron pin in concrete on the East line of M. Brown (1039/426); thence, S.25<sup> $\circ$ </sup>10<sup> $\cdot$ </sup>18"W. a distance of 102.83 feet along said Brown lands to a found iron pipe; thence, N.84<sup> $\circ$ </sup>54<sup> $\cdot$ </sup>50"W. a distance of 102.83 feet along said Brown lands to a set iron pipe on the East line of a public alley; thence, S.22<sup> $\circ$ </sup>15<sup> $\cdot$ </sup>28"W. a distance of 41.53 feet along said alley to the point of beginning.

The above described parcel contains 0.220 acres, more or less, (0.005 acres in lot #2 and 0.215 acres in lot #3) and is subject to all legal easements and right of ways. North is based upon an assumed meridian. All set iron pins are 3/4" x 30" pipes with I.D. caps.
