Taylor's North End Subdivision; Thence North 25° 20'00" East along West line of lot 1 and East Line of Linden Ave. 121.62 feet to an iron pin found at the Place of Beginning, passing an iron pin found at 81.62 feet; Thence continuing North 25° 20'00" East along Linden Ave 40.00' feet to an iron pin found; Thence along Linden Enterprises Volume 1070, page 365 South 64° 40'00" East 136.00 feet to an iron pin found; Thence South 25° 20'00" West along John Wagner Volume 951, page 48, 40.00' feet to an iron pin found; Thence North 64° 40'00" West along Robert & Pamela Edwards Volume 1657, page 605, 136.00 feet to the Place of Beginning. Containing 0.1249 Acres more or less.

Iron pin set are No. 5 reinforced bars 30" inches long with plastic I.D. caps.

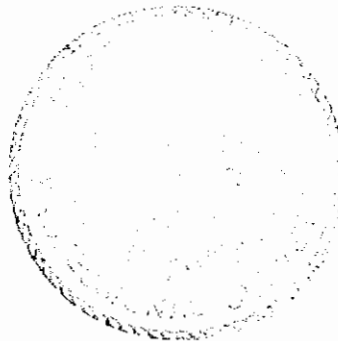

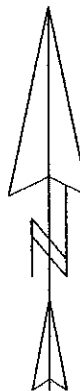

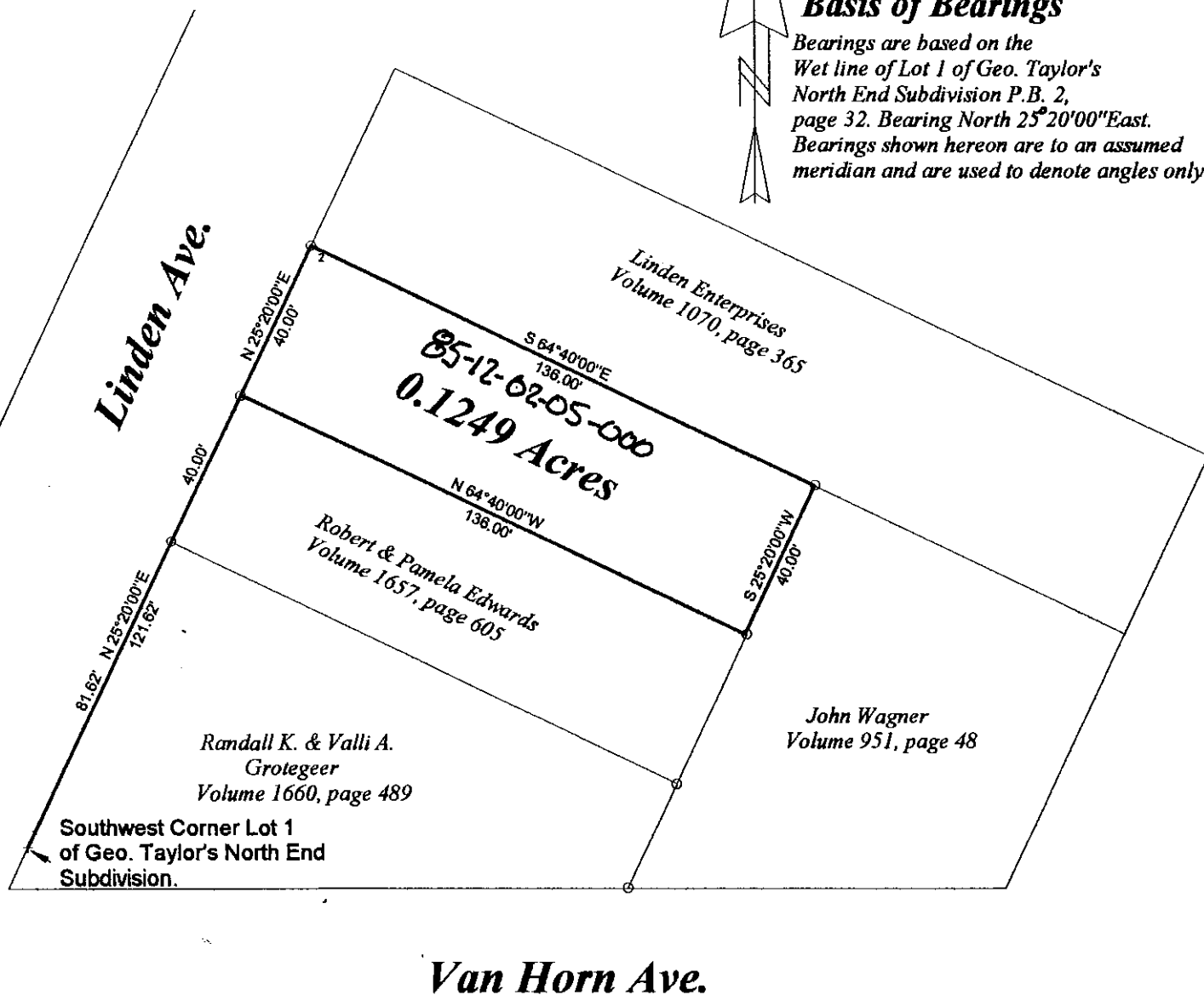


**Plat Of Survey**
