SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING THAT PORTION OF A 15' WIDE PUBLIC ALLEY THAT LIES 120' SOUTH OF NORWOOD BOULEVARD AND BETWEEN ARMCO AVENUE AND AN UNNAMED AND UNOPENED STREET APPROXIMATELY 325' WEST OF SAID ARMCO AVENUE IN THE NORWOOD HEIGHTS AND TILESTON EXTENSION AS RECORDED IN PLAT BOOK 7, PAGES 23 AND 24 OF THE MUSKINGUM COUNTY RECORDS.

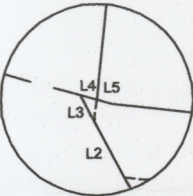
