Situated in the County of Muskingum, State of Ohio, and in the City of Zanesville,
bounded and described as follows:

Being a part of Outlot Number Two (2) of Norwood Heights and Tiledale Extension,
which is of Record in Plat Book 7, Pages 23 and 24, of the Recorder's Office of
Muskingum County, Ohio.

Beginning at the southwest corner of the above Outlot Number Two (2) where the north
line of Englewood Avenue (formerly Tileston Street) intersects the easterly line of a 16
foot alley, said point being marked by an iron pin (axle) found;

Thence run North 21 degrees 18 minutes 00 seconds East along the easterly line of said
alley and the westerly line of said Outlot a distance of 129.94 feet (record: 130 feet) to an
iron pin (5/8 inch rebar) set;

Thence run South 80 degrees 02 minutes 00 seconds East a distance of 74.62 feet (record:
75 feet) to an old 2 inch iron pipe found;

Thence run South 21 degrees 12 minutes 24 seconds West a distance of 130.00 feet to a
¾ inch iron pipe found on the northerly line of said Tileston Street;

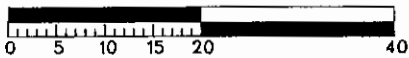

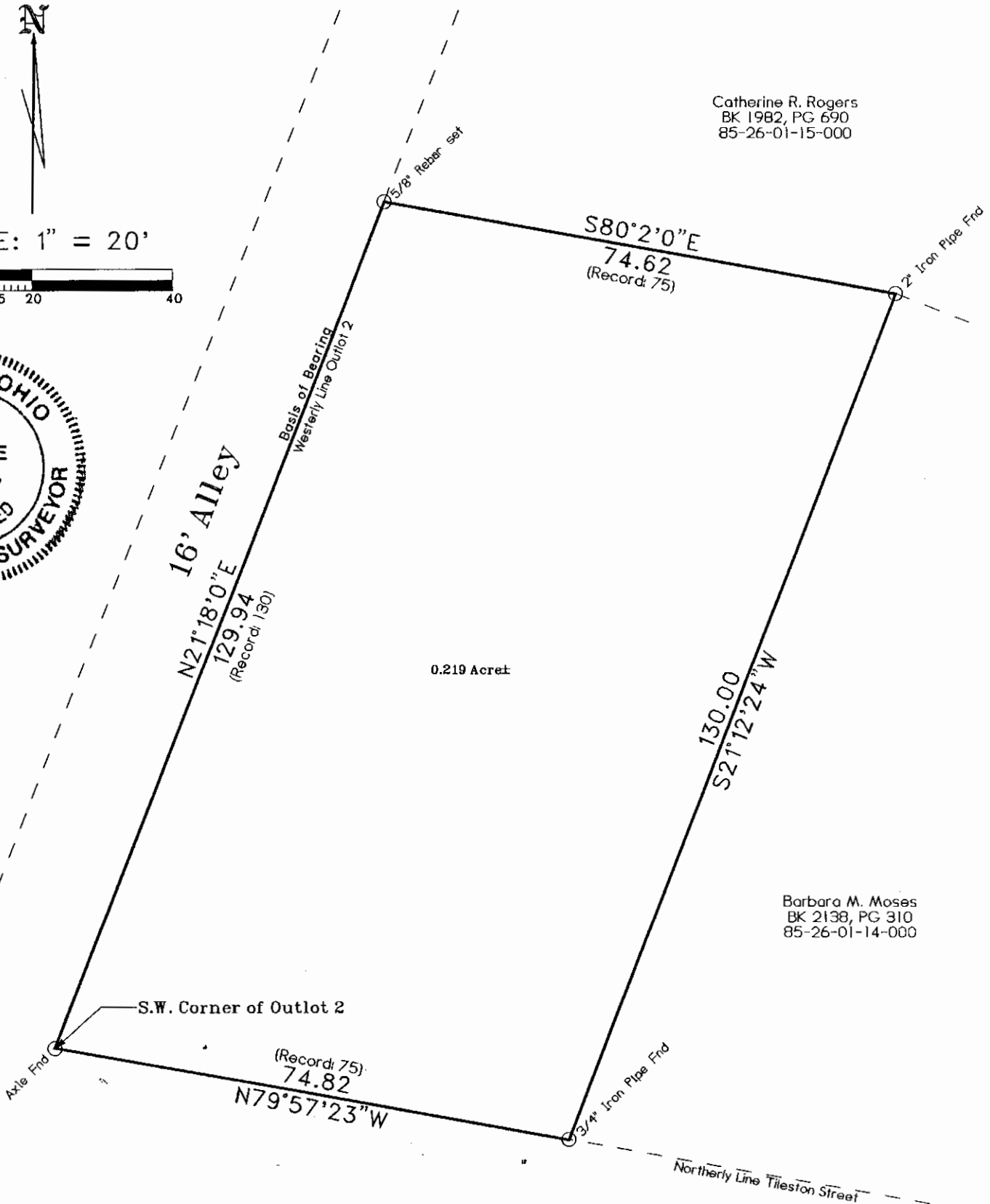
