Situated in the State of Ohio, County of ~~Muskingum~~, City of Zanesville, and being Lot 151 of Norwood Heights Extension as the same is designated and delineated on Muskingum County Plat Book 7, Pages 23 and 24, and bounded and described as follows:

Beginning at a pipe found on the northwest corner of Lot 151 in Norwood Heights Extension as the same is designated and delineated on Muskingum County Plat Book 7, Page 23 and 24;
thence along the north line of said Lot 151 South 52 degrees 47 minutes 33 seconds East 165.52 feet to a point on the north line of Norwood Blvd.

thence along the north line of said Norwood Blvd. on a curve to the left, having a radius of 183.59 feet, a central angle of 11 degrees 27 minutes 19 seconds and a chord bearing South 34 degrees 29 minutes 00 seconds West a distance of 36.65 feet to an iron pipe found on the north line of a 15 foot alley;

thence along the north line of said alley and the south line of said Lot 151 North 68 degrees 13 minutes 57 seconds West 150.80 feet to an iron pipe found on the east line of said 15 foot vacated alley and the southwest corner of said Lot 151;

thence along the east line of said 15 foot vacated alley North 21 degrees 16 minutes 47 seconds East 79.81 feet to the place of beginning, containing 0.21 acres, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the east line of property as described in Muskingum County Deed Book 1116, Page 435 and bearing South 21 degrees 12 minutes 07 seconds West.

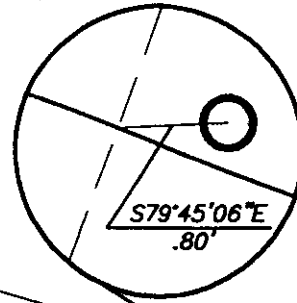
