Commencing at an iron pin found at the Northwest corner of Lot #18 of Maple Hill Subdivision (Plat Book 5, Page 63);

thence along the south line of Somers Street North 90 degrees 00 minutes 00 seconds East 40.00 feet to an iron pin found;

thence leaving the south line of Somers Street South 00 degrees 00 minutes 00 seconds West 100.00 feet to an iron pin found on the south line of Lot 17, said iron pin being 40.00 feet east of the southwest corner of Lot 17;

thence South 86 degrees 01 minutes 22 seconds West 4.48 feet to a point on the corner of an existing block wall;

thence South 01 degrees 12 minutes 54 seconds East 15.09 feet to a point on the back of an existing curb;

thence North 88 degrees 29 minutes 15 seconds East 7.76 feet to a point on the back of an existing curb;

thence South 00 degrees 13 minutes 05 seconds West 34.81 feet to an iron pin set on the south line of Lot 16;

thence along the south line of Lot 16 North 90 degrees 00 minutes 00 seconds West 43.48 feet to a point, being the southwest corner of Lot 16, a monument found being North 78 degrees 39 minutes 21 seconds East 0.33 feet from said corner;

thence along the west line of Lots 16, 17, and 18 North 00 degrees 00 minutes 00 seconds East 150.00 feet to the principle place of beginning, containing 0.14 acres, more or less.

Iron pins set are 5/8 inch rebar, 30 inches long with yellow ID cap stamped DAVIS #7972;

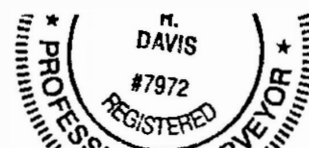

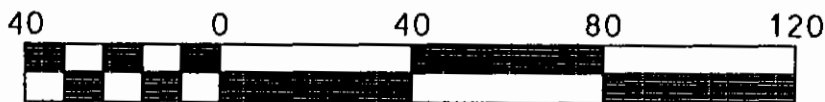
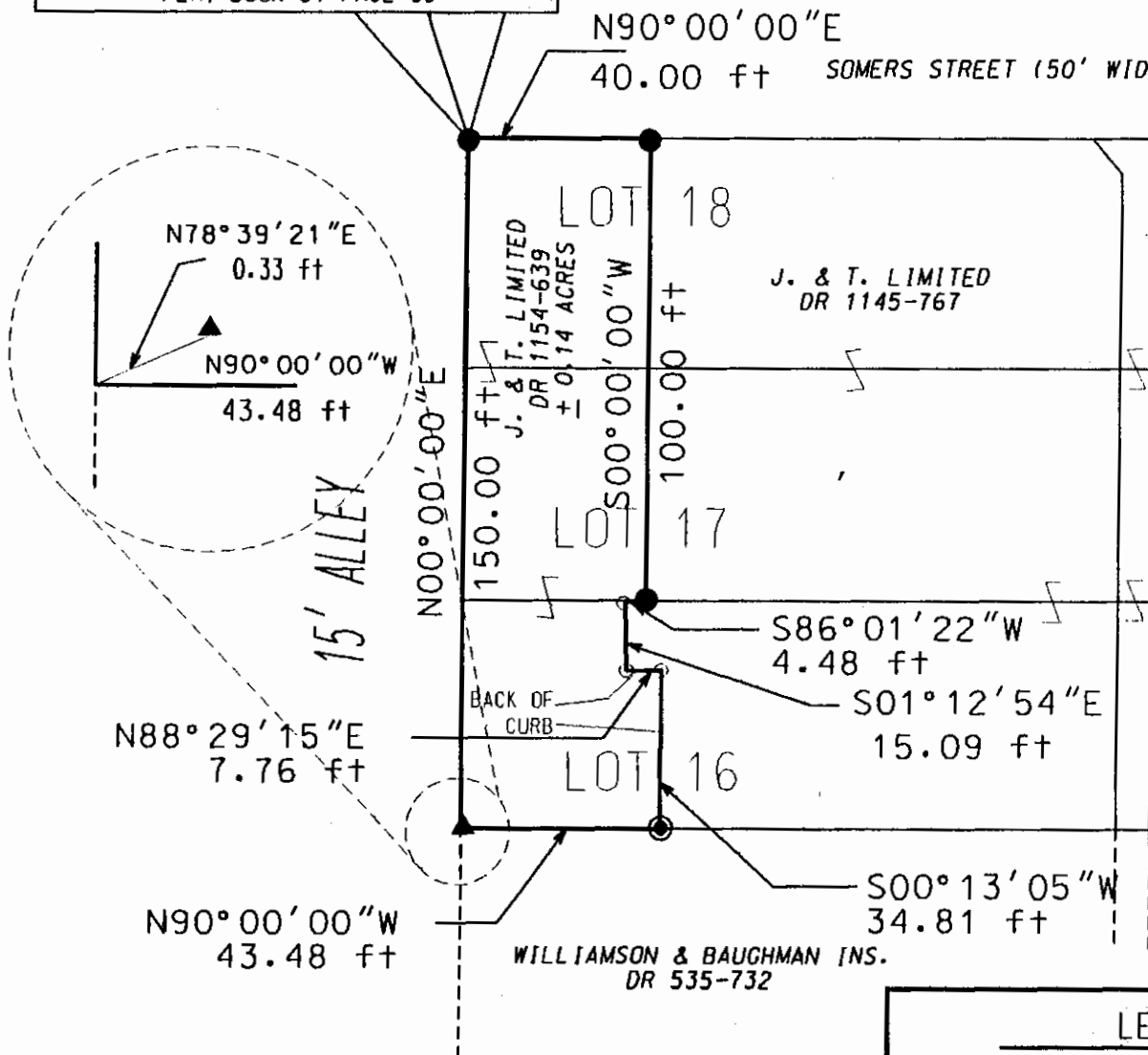
