DESCRIPTION OF SURVEY FOR HABITAT FOR HUMANITY

Beginning at the Northeast corner of Lot #6 of said Glenwood Terrace, also being the Southeast corner of Lot #5 of said Glenwood Terrace;

- #1- thence S 01 57 50 W 53.32 feet along the East lines of said lots #6 & #7, also being the West line of a 1 foot strip included in a 12 foot alley shown on said plat of Glenwood Terrace to an iron pin (set) on the East line of said Lot #7;
