## Survey for L. & R. Miles

Being all of Lots 47 and 48 of Lorimers Subdivision of Lot 1 of Arlington Place (Plat Book 4, Page 17) and part of a vacated alley in the City of Zanesville, County of Muskingum, State of Ohio, and bounded and described as follows:

Beginning at an iron pin found at the northwest corner of Lot 48 Lorimers Subdivision of Lot 1 of Arlington Place (Plat Book 4, Page 17) also being the south line of Taylor Street (50' wide);

thence along the south line of Taylor Street South 86 degrees 23 minutes 00 seconds East 27.80 feet to a point, being the northeast corner of Lot 48;

thence leaving the south line of Taylor Street and along the east line of Lot 48 South 04 degrees 09 minutes 57 seconds West 2.00 feet to an iron pin set;

thence along the east line of Lot 48 and Lot 47 South 04 degrees 09 minutes 57 seconds West 283.73 feet to an iron pin set on the southeast corner of Lot 47;

thence along the south line of Lot 47 North 86 degrees 22 minutes 59 seconds West 27.80 feet to an iron pin set on the southwest corner of Lot 47;

thence North 86 degrees 22 minutes 59 seconds West 10.03 feet to a point in the middle of a 20' wide vacated alley ( Ord. 97-27, 2-24-97);

thence along the centerline of said vacated alley North 04 degrees 09 minutes 57 seconds East 280.73 feet to an iron pin set;

thence continuing along the centerline of said vacated alley North 04 degrees 09 minutes 57 seconds East 5.00 feet to a point on the south line of Taylor Street;

thence leaving the centerline of said vacated alley and along the south line of Taylor Street South 86 degrees 23 minutes 00 seconds East 10.03 feet to the principle place of beginning, containing 0.25 acres, more or less.

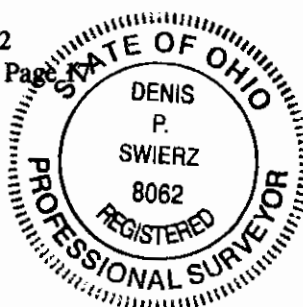

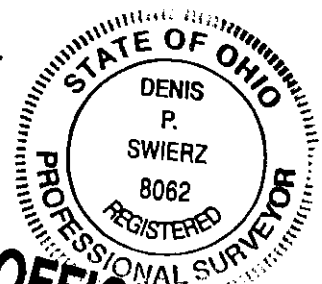
