Being a part of Quarter Township 4, T-1-N, R-8-W, (formerly Falls Township) now in the City of Zanesville, and being more particularly described as follows:

Beginning for reference at the southwest corner of Lot No. 41, Harvard Place as the same is designated and delineated on Muskingum County Plat Book 2, Page 142-1/2;

thence with the south line of said lot extended South 89 degrees 54 minutes 04 seconds West 36.00 feet to a drill hole in concrete on the southeast corner of lands now owned by Zanesville S&B Realty (Deed Record 1088-039);

thence along said Realty's east line North 00 degrees 09 minutes 13 seconds East 211.93 feet to an existing iron pin on the southeast corner of lands now owned by Carl A. Minning, Jr., M.D. (Deed Record 1057-169);

thence along said Minning's south line North 89 degrees 52 minutes 46 seconds West 107.75 feet to the principal place of beginning;

thence North 89 degrees 52 minutes 46 seconds West 46.16 feet to an PK nail set on said Minning's south line;

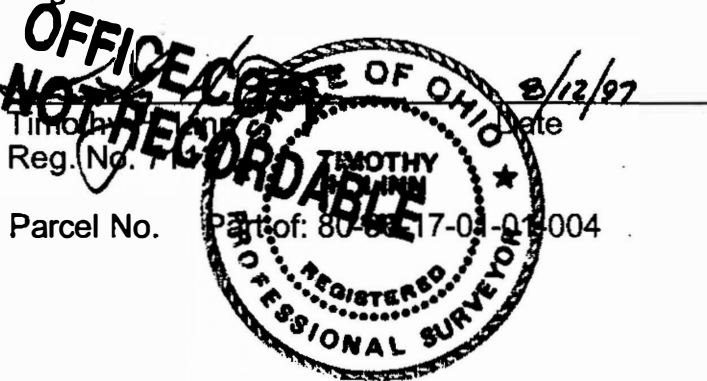
thence along said south line North 58 degrees 20 minutes 27 seconds East 54.29 feet to a point;

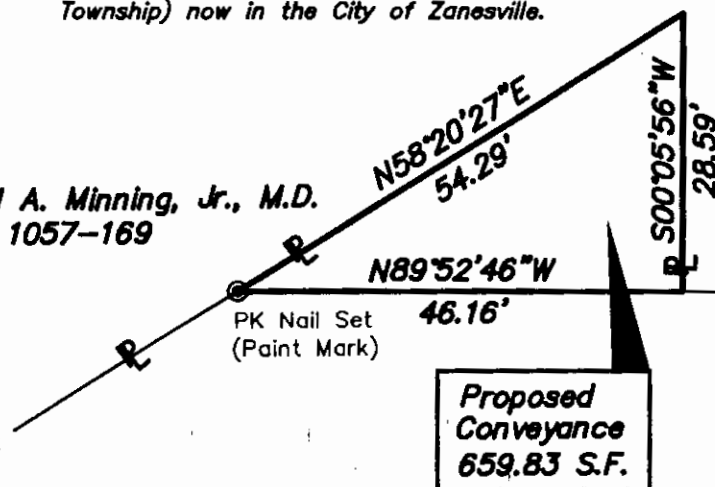
