- 4) South 42 degrees 20 minutes 31 seconds East for a distance of 81.04 feet to a point;
- 5) South 62 degrees 12 minutes 03 seconds East for a distance of 69.46 feet to a point;
- 6) South 38 degrees 53 minutes 19 seconds East for a distance of 50.02 feet to an iron pin to be set after construction on the north line of lands now owned by E. and D. Rogers (DR 753-129);

thence along said Rogers' north line South 83 degrees 32 minutes 40 seconds West for a distance of 142.50 feet to an iron pin to be set after construction;
