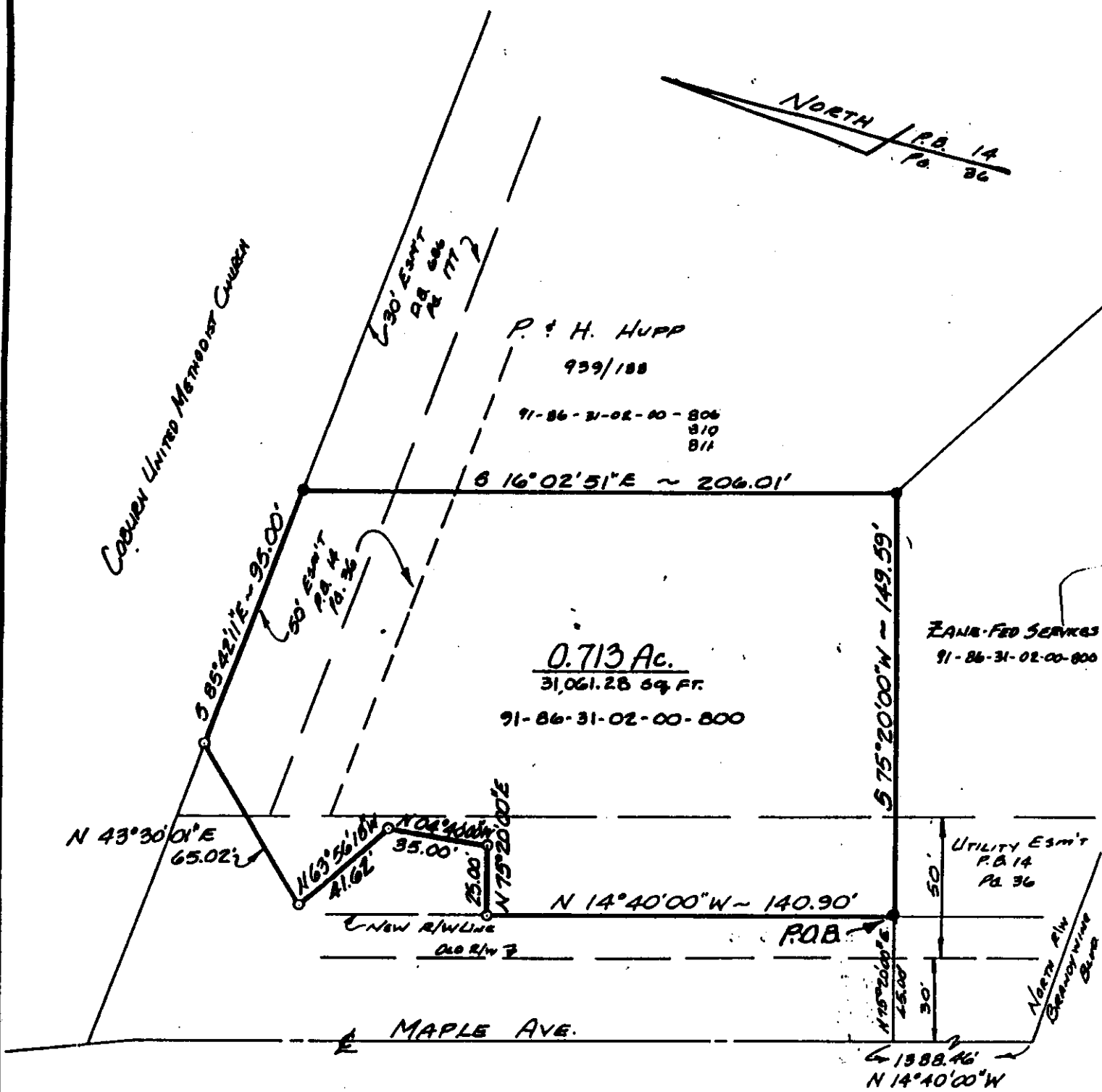

Beginning at an iron pipe found at the southernmost corner of the Hupp tract in the northerly R/W line of Colony Drive (old Northward Circle);

thence, N 58°58'22" W, leaving said r/w line, and along the Hupp's westerly line, 75.00 feet to an iron pipe found;

thence, N 16°02'51" W, continuing along Hupp's westerly line, 110.00 feet to a point;

thence, N 73°57'09" E, leaving said westerly line, 10.00 feet to a point;

thence, S 16°02'51" E, along a line parallel to the Hupp's westerly line, 90.00 feet to a point;

thence, S 43°44'59" E, along a line, 30.25 feet to a point at the corner of an existing parking lot;

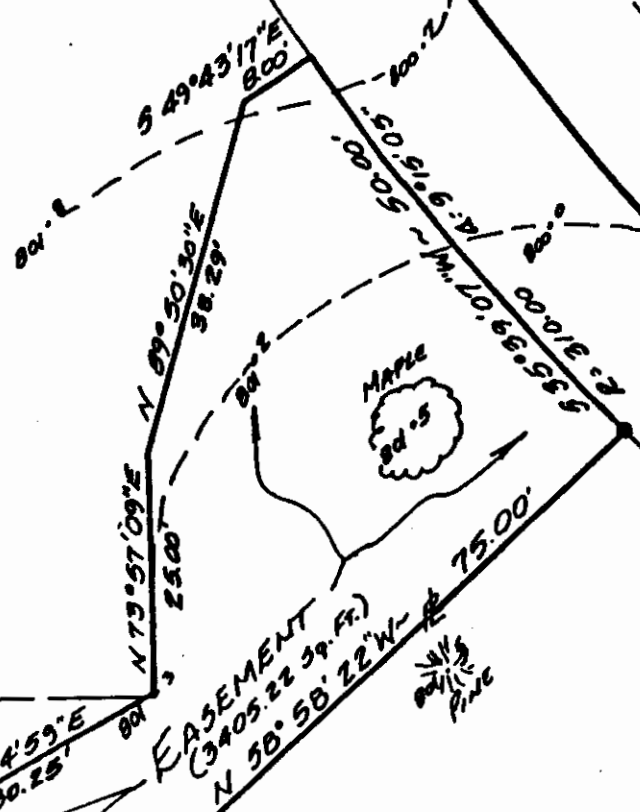
