SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF LOT #9 OF PLAT #2 OF THE BLUFFS AT COLONY NORTH, AS RECORDED IN PLAT BOOK 16, PAGE 3 OF THE MUSKINGUM COUNTY PLAT RECORDS, AND BEING NOW KNOWN AS PARCEL 9-D OF SAID LOT; FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE NORTHEAST CORNER OF SAID LOT #9, THENCE, NORTH 55 DEGREES - 43 MINUTES - 37 SECONDS WEST, 101.44 FEET TO AN IRON PIN SET, PASSING IRON PINS SET AT 62.84 FEET AND 82.15 FEET, AND BEGINNING FOR THE PARCEL HEREIN INTENDED THE TRUE POINT OF то BE DESCRIBED; THENCE, SOUTH 35 DEGREES - 04 MINUTES - 17 SECONDS WEST, ALONG A LINE INTENDING TO BE THROUGH THE AIR SPACE BETWEEN PARCELS 9-C AND 9-D, 97.92 FEET TO AN IRON PIN SET ON THE NORTH LINE OF SOUTHWARD CIRCLE; THENCE, ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 106.18 FEET, A LENGTH OF 39.62 FEET, AND A DELTA OF 21 DEGREES - 22 MINUTES - 48 SECONDS, THE CHORD OF WHICH BEARS NORTH 70 DEGREES - 59 MINUTES - 30 SECONDS WEST, 39.39 FEET TO AN IRON PIN SET; THENCE, LEAVING SOUTHWARD CIRCLE, NORTH 03 DEGREES - 00 MINUTES - 41 SECONDS EAST, 126.67 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 55 DEGREES - 43 MINUTES - 37 SECONDS EAST, 105.10 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.1721 ACRES MORE OR LESS.
