SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING ALL OF LOT #29 AND PART OF LOT #28 OF PLAT 4 - THE WOODLANDS, AS RECORDED IN PLAT BOOK 15, PAGE 145, SAID PART OF LOT #28 BEING BOUNDED AND DESCRIBED AS FOLLOWS:

**BEGINNING** AT AN IRON PIN FOUND AT THE EAST CORNER OF SAID LOT #28, THENCE, SOUTH 64 DEGREES - 18 MINUTES - 21 SECONDS WEST, 27.46 FEET TO AN IRON PIN SET; THENCE, NORTH 65 DEGREES - 18 MINUTES - 02 SECONDS WEST, 72.12 FEET TO AN IRON PIN SET; THENCE, NORTH 43 DEGREES - 52 MINUTES - 24 SECONDS WEST, 60.15 FEET TO AN IRON PIN SET ON THE SOUTHEAST LINE OF EASTWARD CIRCLE; THENCE, ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 564.99 FEET, A LENGTH OF 43.59 FEET, THE CHORD OF WHICH BEARS NORTH 40 DEGREES - 00 MINUTES - 37 SECONDS EAST, 43.58 FEET TO A POINT AT THE MOST NORTHERLY CORNER OF SAID LOT #28; THENCE, SOUTH 47 DEGREES - 34 MINUTES - 53 SECONDS EAST, ALONG THE SOUTHWESTERLY LINE OF LOT #29, 140.80 FEET TO THE POINT OF BEGINNING. 
