Gorsky as Grantors, dated November 6, 1992, owners of an undivided two-thirds interest, for good and valuable consideration paid, GRANT with general warranty covenants to the COUNTY OF MUSKINGUM, OHIO, c/o Board of County Commissioners, 401 Main Street, Zanesville, Ohio, 43701, the following real estate:

- 2. S23°-38'-15"W for a distance of 391.91 feet to an iron pin (to be set);

Thence along said easterly limited access right-of-way line the following two courses:

- 1. $N66^{\circ}-20'-30"W$ for a distance of 13.89 feet to an iron pin (to be set);
- 2. Along an curve to the right having an arc length of 142.31 feet a radius of 1081.74 feet and a chord bearing S37°-22'-57"W for a distance of 142.21 feet to an iron pin (to be set) on the grantor's westerly property line;

Thence N02°-03'-45"E along said property line for a distance of 135.68 feet to an iron pin (to be set) on the westerly limited access right-of-way line of Brandywine Loop Road;

Thence along said westerly limited access right-of-way line for the following three courses:

- Along a curve to the left having an arc length of 302.83 feet, a radius of 1001.74 feet and a chord bearing N26°-27'-21"E for a distance of 301.68 feet to an iron pin (to be set);
