Thence with the southerly line of said 20.33 acre Ray Thomas Lumbertown tract, also with the northerly line of said Shipley's Lot 4, South 87°32'51" East, a distance of 839.70 feet to the southeasterly corner of said 20.33 acre Ray Thomas Lumbertown tract, referenced by a 5/8 inch rebar capped "Enterprise Group" found North 13°48'22" West a distance of 0.70 feet of the corner, said corner also being in the westerly Right of Way line of North Pointe Drive, as shown on the North Pointe Drive and High Pointe Court Dedication Plat, of record in Plat Book 18, Pages 119-121;

Thence with the westerly Right of Way line of said North Pointe Drive, South 13°48'22" East, a distance of 1194.88 feet to an iron pipe set;

- 3) South 69°35'10" West, a distance of 44.88 feet to an iron pipe set;
- 4) Along the arc of a curve to the right having a radius of 20.00 feet, a central angle of 92°32'34", an arc length of 32.30 feet, and the chord of which bears North 64°08'33" West, a chord distance of 28.91 feet to an iron pipe set;
- 5) Along the arc of a curve to the right having a radius of 470.00 feet, a central angle of 27°48'59", an arc length of 228.18 feet, and the chord of which bears North 3°57'47" West, a chord distance of 225.94 feet to an iron pipe set;
- 6) North 9°56'42" East, a distance of 97.95 feet to an iron pipe set;
- 7) North 80°03'18" West, a distance of 60.00 feet to an iron pipe set;
- 8) North 84°38'23" West, a distance of 31.39 feet to an iron pipe set;
- 9) Along the arc of a curve to the left having a radius of 340.00 feet, a central angle of 6°27'37", an arc length of 38.34, and the chord of which bears North 87°52'11" West, a chord distance of 38.32 feet to an iron pipe set;
- 10) South 88°54'01" West, a distance of 379.72 feet to an iron pipe set;
- 11) North 74°59'13" West, a distance of 26.78 feet to an iron pipe set;
- 12) Along the arc of a curve to the left having a radius of 890.00 feet, a central angle of 11°29'03", an arc length of 178.39, and the chord of which bears North 41°31'54" West, a chord distance of 178.09 feet to an iron pipe set;
- 13) North 47°16'26" West, a distance of 169.76 feet to an iron pipe set;
