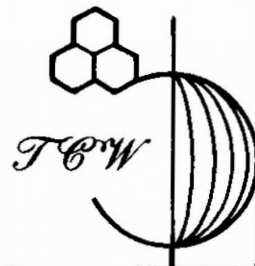

DEED DESCRIPTION

Ohio Textiles

Being a part of Lot 5, Sibley's Subdivision, Plat Book 16, Pages 87 and 88, Township 1 North, Range 8 West, Quarter Township 1, City of Zanesville, Muskingum County, Ohio and being a part of the lands of Zanesville-Muskingum County Port Authority, Volume 1110, Page 30, Parcel #86-34-01-01-000 and being more particularly described as follows:

Beginning, for reference, at an iron pin found at the southeast corner of Lot 5, Sibley's Subdivision, Plat Book 18, Pages 87 and 88, thence North 48° 33' 58" West 3340.58 feet to an iron pin found and the principal place of beginning of the tract herein to be described; thence North 38° 03' 41" West 175.96 feet to an iron pin found, passing and iron pin found at 7.78 feet; thence North 65° 15' 07" East 15.00 feet to an iron pin set; thence South 33° 13' 29" East 173.12 feet to the place of beginning. The tract as surveyed contains 0.03 acres, more or less, subject to all highways and easements of record.

Bearings in the above description are based on the east line of Lot 5, Sibley's Subdivision, Plat Book 18, Pages 87 and 88 bearing North 02° 32' 09" East.

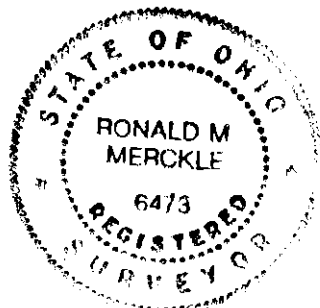

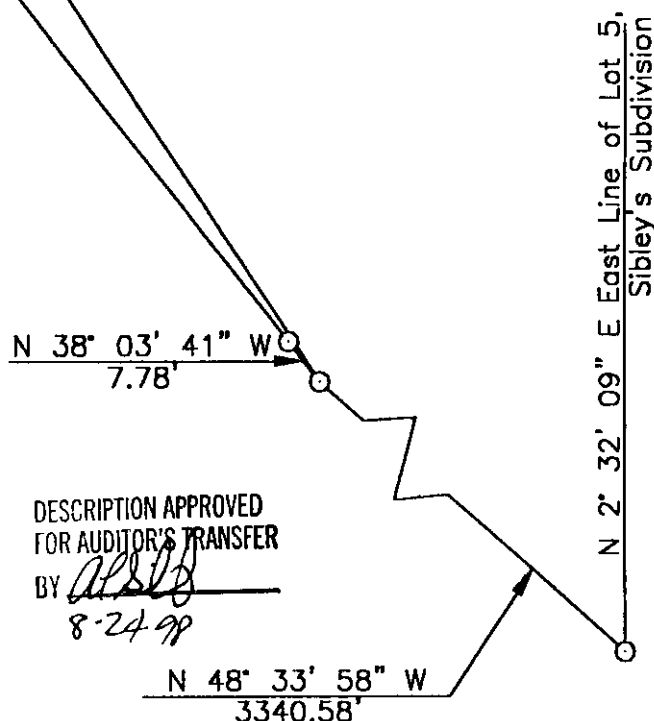

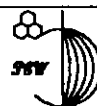
