

DESCRIPTION FOR 21.310 ACRE PARCEL

Situated in the State of Ohio, County of Muskingum, City of Zanesville, Quarter Township 1, Township 1, Range 8, being a part of Lot 5, Sibley's Subdivision, Plat Book 16, Page 88, and being a part of 49.67 acre tract as conveyed to the Zanesville-Muskingum County Port Authority by deed of record in Volume 1110, Page 28, all references being to those of record in the Recorder's Office, Licking County, Ohio, said 21.310 acres being more particularly bounded and described as follows:

Commencing at a iron pin found at the intersection of the westerly right-of-way line of Northpointe Drive and the northeasterly corner of 10.5507 acre tract as conveyed to Autumn Health Care of Zanesville, LLC. by deed of record in Volume 2059, Page 14;

Thence along the northerly line of said Autumn Health Care of Zanesville, LLC. tract, North 52°43'52" West, 541.53 feet to an iron pin found and the Point of Beginning of the parcel herein described;

Thence continuing along the northerly line of said Autumn Health Care of Zanesville, LLC. tract, South 84°11'49" West, 564.04 feet to a point, said point being North 17°20'37" West, 2.02 feet from an iron pin found;

Thence along the easterly line of a 104.2 acre tract as conveyed to Robert Dale Vandenbark by deed of record in Volume 1542, Page 850, North 02°00'50" East, 1,736.01 feet to an iron pin found in the southerly right-of-way line of Fairview Road;

Thence leaving the aforesaid easterly line and along the southerly right-of-way line of said Fairview Road, with a curve to the left having a radius of 580.00 feet and an arc length of 103.70 feet, said curve having a chord bearing of North 75°51'59" East and a chord length of 103.56 feet and being subtended by a delta of 10°14'38" to an iron pin found at the northwesterly corner of a 3.491 acre tract as conveyed to Strumco Partners, LLC. by deed of record in Volume 1145, Page 403;

Thence leaving the said southerly right-of-way line and along the westerly line of the aforesaid Strumco Partners, LLC. tract, South 01°57'24" West, 447.08 feet to an iron pin found at the southwesterly corner of said Strumco Partners, LLC. tract;

Thence along the southerly line of said Strumco Partners, LLC. tract, South 88°01'47" East, 315.00 feet to an iron pin found at the southeasterly corner of said Strumco Partners, LLC. tract;

Thence along the easterly line of said Strumco Parterns, LLC. tract, North 01°57'24" East, 410.04 feet to an iron pin found at the northeasterly corner of said Strumco Partners, LLC. tract;

Thence South 68°42'25" East, 295.86 feet to an iron pin found;

Thence South 23°02'21" East, 533.99 feet to an iron pin found;

Thence North 77°03'44" West, 149.28 feet to an iron pin set;

Thence South 21°17'59" West, 281.14 feet to an iron pin set;

Thence North 68°33'54" West, 223.98 feet to an iron pin set;

Thence South 01°36'00" West, 719.68 feet to an iron pin set;

Thence North 89°45'12" East, 206.07 feet to an iron pin set;

Thence South 75°28'08" East, 21.68 feet to an iron pin set;

Thence South 16°53'34" West, 168.93 feet to an iron pin set;

Thence North 52°43'52" West, 65.09 feet to an iron pin found;


Thence South 37°16'08" West, 80.00 feet to the Point of Beginning and containing 21.310 acres, more or less, according to a survey conducted by Jobes Henderson and Assoc. in 2007.

The bearings in the above description are based on the Ohio State Plane Coordinate System, Ohio South Zone, NAD83.


All iron pins set are 5/8" rebar by 30 inches in length with red surveyors identification caps marked "J&H, PS 8283".
