

Commencing at a stone found at the Northwest Corner of said Lot 6; thence south 1 degree 57 minutes 06 seconds west 1234.68 feet to an iron pin found; thence south 88 degrees 35 minutes 33 seconds east 1436.47 feet to a point; thence north 21 degrees 43 minutes 05 seconds east 129.36 feet to an iron pin found; thence north 1 degree 39 minutes 40 seconds east 76.95 feet to an iron pin found; thence north 16 degrees 56 minutes 05 seconds east 90.51 feet to an iron pin found at the northeast corner of a 2.65 acre parcel conveyed to Othello R. Repuyan by deed recorded in Deed Book 1642, Page 425; thence north 2 degrees 32 minutes 05 second east 335.0 feet to a concrete monument found at the northeast corner of a 16.125 acre parcel conveyed to Northpoint Development Co. Ltd. by deed recorded in Deed Book 1148, Page 838; thence north 69 degrees 44 minutes 51 seconds west 100.0 feet to an iron pin found and the true place of beginning of the premises herein intended to be described; thence south 63 degree 47 minutes 13 seconds west 394.75 feet to an iron pin found on the edge of a culdesac at the end of James Court as recorded in Plat Book 18, Page 28; thence along said culdesac on a curve to the left having a radius of 50 feet an arc length of 45.64 feet (the chord of which bears north 76 degrees 54 minutes 41 seconds west 44.08 feet) to an iron pin placed; thence north 26 degrees 56 minutes 17 seconds west 201.61 feet to an iron pin placed; thence north 65 degrees 14 minutes 36 seconds east 98.04 feet to an iron pin placed; thence north 25 degrees 12 minutes 56 seconds west 17.99 feet to an iron pin placed; thence north 5 degrees 30 minutes 43 seconds west 60. 14 feet to an iron pin placed; thence north 14 degrees 39 minutes 41 seconds west 22.62 feet to an iron pin placed; thence south 69 degrees 44 minutes 51 seconds east 446.13 feet to the true place of beginning, containing one and eighty hundredths (1.80) acres more or less.
